Directions to Syracuse Obedience Training Club

SOTC Training Facility, 6392 Deere Road, Syracuse, New York

From Thruway: Take Exit 35. At Carrier Circle, take 2nd exit onto Route 298 West. Turn left onto Deere Road (4th building on left)

From North Midler: Turn right onto Court Street Road, then left onto Deere Road (2nd building on right).

The building is directly across from the John Deere building and has a sign for Ansun Graphics on the front. Main entrance is on the side facing Court Street Road, toward the rear of the building and around the corner from the garage door. HONYASC Dog show signs will be at the corner of Route 298 & Deere Rd. & in front of the Ansun Graphics building.

This trial will be held under the current rules and regulations of ASCA. No entry shall be accepted from a dog or handler disqualified from the ASCA Conformation program; a dog or handler disqualified from all ASCA programs; or a person not in good standing with ASCA.

Classes offered:

JUNIORS: Pee Wee & Sub Juniors (no further competition); 8 – 12 & 13 – 17 (Divided into Novice & Open) Class winners to compete for Best Jr. Handler and Reserve Jr. Handler.

NON REG: 2 – 4 & 4 – 6 months (divided by sex); class winners to compete for BOB & BOS puppy.

SWEEPSTAKES: 2-4 month, 4-6 month, 6-9 month, 9-12 months, 12-18 months (all divided by sex); class winners to compete for Best in Sweepstakes.

ALTERED: 6 – 9, 9-12, 12 – 18, Novice, Am. Bred, Bred by Exhibitor Open Blue Merle, Open Red Merle, Open Black & Open Red (divided by sex). Class winners compete for Winners Dog / Winners Bitch. Alt. Winners Dog & Bitch will compete with Alt. Specials for Alt. BOB, BOS & BOW.

INTACT: 6 – 9, 9 – 12, 12 – 18, Novice, Am. Bred, Bred by Exhibitor, Open Blue Merle, Open Red Merle, Open Black & Open Red (divided by sex). Class winners to compete for Winners Dog / Winners Bitch. Winners Dog & Winners Bitch will compete with Specials for BOB, BOS and BOW.

OBEDIENCE: Sub-novice, Novice A&B, Graduate Novice, Open, Utility, and Wild Card.

Awards: Ribbons: 1st through 4th in all classes and qualifying scores.
