Courses: Saturday Courses will be Course D for cattle and sheep
Course A for ducks
Sunday Courses will be Course B for all livestock

Livestock: Cattle- 3 Hereford Crosses or Dexters per run (12-15)
\$55 per run

Sheep- 3 Katahdin or Border Cheviot crosses per run(15-18)
\$45 per run

Trial 1 Saturday and Trial 2 Sunday will be Katahdins
Trial 2 on Saturday and Trial 1 on Sunday will be Cheviots

Ducks-5 Magpie or Call ducks per run (18-20)
\$30 per run

Trial 1 on Saturday and Trial 2 on Sunday will be Magpies
Trial 2 on Saturday and Trial 1 on Sunday will be Calls

******Injured livestock expenses including veterinary and disposal fees will be the responsibility of the handler/owner. Replacement costs of livestock are ducks \$25, sheep \$175 and cattle \$900 per head.**

Handler's Meeting: 8 a.m. both days and trials will begin immediately following

Run orders: will be determined and posted in advance of the trials. Please plan to run your dogs in order in the sheep and cattle arenas especially to keep the trials moving along during each day.

***Bitches in Season will run in order and must be crated otherwise. All dogs must be on leash when not competing in the arenas.**

Trial Awards: Ribbons and prizes will be presented for 1st-4th placements on each class of livestock in each division. A HIT Aussie and HIT Non-Aussie will be presented for each trial
