#### Information

These shows and trials will be held under the current rules and regulations of the Australian Shepherd Club of America. No entry shall be accepted from a dog or handler disqualified from the ASCA Conformation program: a dog or handler disqualified from all ASA programs, or a person not in good standing with ASCA.

ASCA sanctioned rally trials are open to all breeds and mixed breeds eligible for registry with another club (including AKC and AMBOR). This is an actual trial and dogs of all breeds are eligible for titles. Dogs with titles or legs in other registries must begin at the novice level in ASCA. Visit the ASCA site for more details (<a href="www.asca.org">www.asca.org</a>). To enter in rally, a dog must have an ASCA tracking number or ASCA registration number. Details on obtaining this can be found on the ASCA website (<a href="www.asca.org">www.asca.org</a>).

All conformation classes will be held outside on grass. Shade tents will be set up at the entrance to the ring. Rally classes will be held on dirt in enclosed horse arena. In case of inclement weather, conformation classes will be held on dirt in enclosed horse arena. Electric outlets are available; please bring heavy-duty extension cords to prevent loss of power.

Show grounds will be available to exhibitors Friday afternoon for camping site set-up. Please be sure you have filled out a reservation slip and make check payable to SCHAGHTICOKE FAIRGROUNDS. Please pick up after your dog, and police your grooming space and camping site for dog hair. All trash should be brought to the dumpster provided, no trash cans at the camping sites.

Directions: from SOUTH – NY Thruway (I-87) to exit 23, take Rte I-787 north to exit 9 (Rte 7 east, Troy/Bennington, turn left at the next light (Rte 40 N). \* Continue north on Rte 40 through Troy, past cemetery, following Rte 40 N. Go through the village of Schaghticoke until you see fairgrounds on your left. Proceed to the light, turn left onto Co. Rte 125 (Stillwater Bridge Rd), and turn left into fairgrounds.

From EAST – Take Rte 7 west to Troy. Just before the Hudson River bridge, turn right onto Rte 40 N. (little white church on corner, Stewart's on opposite corner, and follow from \* above.

From WEST – NYS Thruway (I-90) to exit 24, take exit 1 n (I-87) Adirondack Northway to exit 7 (Rte 7 east). Turn left at the next light onto Rte 40 north, and follow from \* above.

From NORTH – Adirondack Northway to exit 12/Rte 76, follow Rte 67 east to the junction of Rte 40, turn left onto Rte 40 N, go through Schaghticoke until you see the fairgrounds on your left, turn onto Stillwater Bridge Rd., and left into the fairgrounds.
