High Scoring Aussie will be awarded at each trial if the High in Trial winner is not an Australian Shepherd.

HIGH IN TRIAL CIRCUIT: ribbon will be awarded to the dog/handler team with the highest average score of their 3 highest scores from the weekend. 1 score must come from obedience and 1 score must come from rally the 3rd score can come from obedience or rally. Handlers should submit their 3 highest scores from the weekend after their last run on Sunday.

ASCA Rules

This event will be held under the current rules and regulations of the Australian Shepherd Club of America (ASCA). No entry will be accepted from a dog or handler disqualified from all ASCA programs; or a person not in good standing with ASCA. ASCA rules require each dog entered to be ASCA registered. For more information on registering your dog with ASCA or for an official ASCA Rally or Obedience entry form go to www.asca.org "Day of" entries taken if entry limits are not reached by closing date. "Day of" entries must be presented to trial secretary at least a ½ hour before start of trial. After the pre-entry deadline, all obedience entries will receive notification by email of the approximate time their classes will start. Please include your email address on your entry form. Day of entries may require class times to be adjusted. All Obedience dogs must have an ASCA CD before entering Open and have an ASCA CDX before entering Utility. All Rally Dogs must have an ASCA Novice title before entering Advanced, an ASCA Advanced title before entering Excellent and an ASCA Excellent title before entering Masters.

Directions to Top Dog Obedience School

Top Dog Obedience School is located at 24 Bartley Road, Flanders, New Jersey 07836.

Most GPS devices will get you to Bartley Road, but for some reason they do not take you all the way to the door. Once you turn on Bartley Road from 206, it is approximately one mile to our site. It is best to use the mapquest directions below.

From Route 80 East or West (exit 27A) to Route 206 South: Go 4 miles, turn right onto Bartley Road, just before the railroad overpass. Go about a mile to Top Dog on the right.

From Route 287 (exit 22B) to Route 206 North: Take 206 through the town of Chester and cross the intersection of 206 and 24/513. Stay on 206 to the second traffic light and make a left onto Bartley-Chester Road. Cross over the railroad tracks. Turn right and then make an immediate left to Top Dog.
