### **Directions:**

#### From Rt 2 heading East

Take Rt 2 to exit 24 (Rt 140, go left onto 140. Follow to second set of lights, junction of Rt 101, take a right 101 heading towards Ashburnham. Follow 101 for a few miles to a flashing yellow light. At the light turn left onto Corey Hill Rd. (\*) Follow for about 1 mile to end to a flashing red light, go straight across intersection onto Lashua Rd. Follow to end and take a left onto Lake Rd. Follow for about 2 miles to a fork. (\*\*) At fork bear right onto Harris Rd. Lane Ln will be on your right just up a little ways. We are the first driveway on the right, log cabin style home.

#### From Rt 2 heading West

Take Rt 2 West to exit 27 (Narrows Rd/Depot Rd). At end of exit take a right onto Depot Rd. Follow to a stop sign and take a right onto 2A. Go under railroad bridge, then over a small bridge. After the bridge take a hard left onto South Ashburnham Rd. Follow for about 6 miles to a flashing red light, go straight across intersection onto Corey Hill Rd. Follow from (\*) above.

#### From Rt 119 heading East and West

Follow to junction of Rt 101 in Ashburnham. Turn onto 101 South. Follow for several miles to junction of Rt 12 in Asburnham center. Turn right onto Rt 12, follow 12 through the center of town and past Cushing Academy. Take a right onto High St (turns into Lake Rd). Follow for about three miles to the fork and (\*\*) above.

#### • Junior Handler Entry Fees

- In January 2004, ASCNE voted that entry fees for Junior Handlers for all performance events should not exceed 50% of the published entry fee. In order to be eligible for the Junior entry fee rate, the Junior had to own or co-own the dog being entered
- o Currently ASCA Obedience rules prohibit special fees.
- o Linda Gray indicated the stock rules were also being clarified to prohibit special fees.
- Going forward, at ASCNE events, juniors will pay 1/2 price entry fees for everything except obedience. A junior must own or co-own the dog to be eligible for the 1/2 price.
- o Stock entry fees for juniors will be reviewed when the clarifying motion is received from ASCA.

#### • Electronic Newsletter

- It has been mentioned before about doing an electronic newsletter. This would greatly reduce the cost of the newsletter. Right now we pay roughly \$200 postage, \$15 for envelopes, the printing has been free - but this will no longer be.
- o Different questions and concerns were raised:
  - Could it be sent on ASCNE-I and emailed to ASCNE members not on ASCNE-I.
    - Could it be put on the website. We have newsletter only members and it would not be fair to pay for something that anyone can view.
  - Can there be a "members only" section of the website.
  - If it was emailed, then email addresses would need to be verified and servers may shut you down for too many emails if they think you are sending spam.
  - Is there a requirement in the by-laws that says we have to put out a newsletter.
  - It was decided that it should be brought up at the March meeting for a larger member input.

## Affiliate Report, January – May 2007 – Sheila Dolan

#### January:

- Approved retaining Chuck Carnese as ASCA attorney for 2007.
- Approved revision of a previous motion and counting of substitute stock dog trial judges' scores.

#### February:

- ASCA will accept contact equipment that meets the specifications of any of the following agility organizations: AAC, AKC, CKC, CPE, DOCNA, NADAC or USDAA.
- There is a new requirement for DNA submission. A copy of the dog's ASCA registration or other ASCA-approved
  registration in the case of hardship or foreign-registered dogs must accompany the DNA submission. If the dog is
  unregistered, a copy of the litter registration or copies of the sire and dam's registrations will suffice. If the dog's
  parentage is unknown, this must be stated on the submission.
- Change to National Specialty Guidelines: Individual detailed expense reports for all ASCA Finals including Juniors must be postmarked to the Executive Secretary no later than six months after the last day of Nationals. Expenses submitted later will not be paid. Reports may include but are not limited to complete accounting of judges' expenses, ribbons/trophies, equipment, etc. Receipts are required.
- An expenditure of \$18,000 was approved to add or upgrade software that replace the aging fileserver and will allow member login and improve functionality. (3<sup>rd</sup> quarter)
- An expenditure was approved in the amount of \$14,086.97 to reimburse West Coast Australian Shepherd Club for National Finals expenses for **2004**!!!
- Agility judges from other major agility organizations may apply to be ASCA judges provided they are fully approved judges, have completed three sanctioned judges' assignments in the other organization, and have titled at least one dog at the top level of an organization.
- Agility premiums should be distributed 5 weeks in advance of an event and must include a description of prizes/awards as well as how HIT (if offered) is decided; also contact info for the trial chair and trial secretary.
- Service membership increased from \$8 to \$10 on June 1, 2007.
- Registration fees also increased on June 1: 0 -1 year, \$15 member, \$30 service; 1 2 years, \$30 and \$60; 2+ years, \$50 and \$100. Breeder discounts of \$3 per pup for an entire litter remain for ASCA members.
- Late fees for submitting show/trial results are increased from \$1 to \$10 per day.
- Litter registration fees increased to: 0-6 months, full \$21, service \$42; 6-12 months, full \$30, service \$60; 12-24 months, full \$55, service, \$110; and 24 months +, full \$55, service \$110.
- New judges approved: Nonregular: Libby Graham, CO; Tammy Seaman, NM; Laura Diebold, CA; Kerry Kirtley, CA. Provisional judges: Pamela Nelson, AL; Maarten Walter, OR; and Heather Herron, MI. Senior Breeder Judges: Anne Shope, NM and Sandy Rees, AZ.

#### March:

• Random order of exercises in Open B obedience approved.

#### April:

- The Conformation Invitational will become the Conformation Finals in 2008.
- Members of an agility judge's family or household may show under him/her FEO only.
- Catalogs and event membership dues (.50 per run) must include scratches, eliminations, and FEOs.
- Judges' yardage and course times records plus copies of courses with any changes noted must be included in the paperwork package to the BO.
- Clubs may offer FEO and pre-Novice classes. No prizes or placements for FEO, no teeter or weaves in Pre-Novice.
- Juniors may choose to run their dogs at standard height or 4" lower.
- HOFX motion made by Anne Shope defeated.
- New timeline for BOD candidates approved. (Filing forms available in this report.)
- Transfer fees increased from \$12/24 to \$15/30.
- Only full members eligible for Finals or Merit programs.
- Breeder's signature required on Foreign Registry application. (This was inadvertently omitted in the rules.)
- New judges: Nonregular: Judy Chard, CA and Elizabeth Ann Morgan, CO. ASCA Breeder Judges: Claire Gustafson, NC, and Susan Moorehead, NC. ASCA Senior Breeder Judge: Mary Quam, WI. Agility judges: Trisha Stall, Kent Mahan, and Darryl Warren.

#### May:

• Changes made to the tracking judges' requirements are available in this report.

• An expenditure of \$2,385 was approved for a security/surveillance system for the BO.
