From Rt.95 South of Attleboro: Take Exit 2A (Newport Ave.) to the 2nd light. Take that left onto Benefit St. At the next light bear left onto Central Ave. to the end. Take a left onto Rt. 152 (Newman Ave.) Go ½ mile and take a left onto Pond St. Watch for the Orion Industrial Park on your left (2/10 mile). Turn into the park, we are the second building on the left.

From Rt.95 North of Attleboro: Take Exit 3A Rt. 123. At the 2nd set of lights take a right onto County St. Follow along and after the Stone E Lea golf course take a left onto Read St. (There are signs for the animal shelter). Take the 2nd right onto Pond St. Turn right into the Orion Industrial Park in approximately 3/10 mile. We are the 2nd building on the left.

## SECRETARY'S REPORT

Minutes from the November 4, 2007 meeting held at Robin Goodman & Hollis McGuire's in Milford, NH.

President Jean Janotta called the meeting to order at 12:45 pm.

## Secretary's Report – Gull Reidy

o Minutes from the September meeting were accepted as printed in the New England Aussie Newsletter.

## • Treasurer's Report - Dottie Duclos -

- The treasurer's ASCNE report was approved as follows:
  - General Cash 11/4/07 \$25,502.67
  - Rescue Treasury \$2,740.54
  - Total \$28,243.21
- The only event held since the last meeting was the 2007 ASCA Nationals and Finals. There will still be some adjustments to these figures, but this is where we stand now.
  - Nationals balance \$33264.08
  - Outstanding bills \$13172.18 (of which \$5255.25 is the amount ASCNE put in up front) and the fairgrounds electric bills have yet to be received.
  - The initial contribution of \$1000 from each of the consortium clubs has been repaid (except for the above mentioned extra amount from ASCNE). All were in agreement that if there is a profit, ASCNE should be refunded the \$5255 prior to the distribution of profits amongst the clubs.
  - It appears a profit will be made. This will be split among the consortium clubs. (If you worked at the Nationals, be sure to contact the chair of the venue and let them know. The profit will be divided according to number of volunteers from each club.)

#### • Affiliate Report - Sheila Dolan

- o Jean read a report from Sheila. The report in its entirety is included at the end of the minutes.
- o There are quite a few changes to Agility rules. The biggest being opening gamble times have been cut from 40 to 30 seconds, and point accumulation has also been reduced novice 15, open 18, elite 21.
- o In stock, rules will be modified to allow discounts for working junior and novice handlers.

## Affiliate Report Submitted by Sheila Dolan

#### July (all agility):

Change in Novice level agility rules - it is recommended but \*no longer required\* that segments of the course that encourage a change of handling sides take place in a tunnel or while executing the A-frame. (Reason: Improved training/handling at Novice level.)

Premium must include all reduced entry fees or discounts, must describe all prizes offered, and must include a copy of the Tracking Number and Service Member Applications.

Change in gamble times - a serpentine \*may\* now be considered a challenging sequence, depending on the judge, who may add one or two seconds. (Before this it was always considered a challenging sequence.) Rationale same as above, improved handling and training. New additional sentence: No gamble shall ever be 3 seconds less or more than the base gamble time for each level.

Exiting the ring not on leash and/or under handler control is an E. \*Gentle\* tugging on the leash may be allowed while exiting, but dogs may not under any circumstances target their leashes after the last obstacle.

## August:

Opening gamble time has been cut from 40 to 30 seconds, with a reduction in minimum point accumulation required to Novice, 15; Open, 18; and Elite, 21. This is a time-saving measure.

The SDC has been instructed to modify the Stockdog Rules to allow discounts for Working Junior Handlers and Novice Handlers.

Each new committee created by ASCA is required before all else to write a Mission Statement (within 90 days of committee formation). BOD will approve Mission Statements.

A disclaimer will appear in 18-point font or larger on the inside front cover of all rulebooks stating that ASCA National Specialty Rules differ from program rules in certain instances; National Specialty rules should be accessed on the website or sent for.
