- Take Route 3 north to exit 8 in Nashua, towards Amherst and Milford.
- Follow signs towards route 101A West towards Milford and Keene.
- Stay on 101A west for through Nashua, Merrimack, and Amherst.
- Go past the junction of 122 and 101A to Route 101 West, towards Keene.
- Take a left onto 101 West; get off at the first exit, Route 13.
- \*\*\*At the end of the exit ramp, take a left onto Route 13 heading south.
- Take a right at the light onto Armory Street.
- Continue on Armory Street for a mile. Take a right at the stop sign onto Osgood Road.
- Take the next left onto Mason Road. Go 3.0 miles.
- At the three mile point on the right is a mail box with the names Goodman McGuire and on the left is a sign with McGuire & Goodman. The street number is 648.
- The driveway is long and splits in tw;; keep to the left at the split.

#### From the Manchester Area:

- From Manchester, take Route 101 West to the Route 13 exit in Milford.
- Follow \*\*\* above

#### From the west:

- Take 101 East towards Milford.
- Look for signs for the intersection of 101 east and 101A east.
- At the intersection of 101East and 101A East, go right onto 101 East.
- Take a right at the next stop light. (State Police Barracks and Market Basket are on the right) this is Old Wilton Road.
- Old Wilton Road becomes Savage Road at the road just after the Market Basket. Stay on this road for 2 miles.
- Bear right at the fork continuing on Savage Road.

2 weeks from the day of the meeting we will be finishing day two of the Stock dog Finals and having the Agility Finals.

- All committee members should be very careful keeping track of receipts for reimbursement from ASCA. Peter Kontos will put together folders for the judges to keep track of their expenses, otherwise it's up to the committee chairs.
- Right now ASCA's pay back is in the area of \$10,000.
- Total revenues \$174892.00 Expenses \$30439.70 Cash available \$144452.21 Start up monies \$10255.25 Finals Sponsorships \$20662.25 Pay-pal set up \$.17 Cash checking and on hand for deposit \$175369.88
- The projected budget is coming out ok, if fact a little lower than projected.
- Most of the revenue has been generated, there will be some additional monies from merchandise sold, vendors and minor things.
- Some big expenses, such as ribbons, are still to be paid.
- RVs and stalls are lower than projected, the RV expenses will be proportionately lower.
- Entries are higher than projected.
- We need to be out of the stock area on the Friday as an Appaloosa Horse show will be coming in.
- Pete is getting a box truck, loading it and driving down the previous Tuesday.
- Renee Reschenthaler has been a tremendous help, as has Michelle Durkin and Kathy Glaes.
- The idea of a Thank You gift to a few non-members who have been of great help was discussed.
- A couple of bumps in the road included ASCA only approving 2 of the Finals budgets. All have been approved now. A
  new conformation judge had to be approved by ASCA. The office added more dogs to the Stock dog Finals because all
  the runs had not filled.
- The vendor building is full.
- Entries are completely sponsored.
- There are about 1100 entries.
- Karen Miller has done veoman's work on entries.
- Karen Thurlow has done yeoman's work on the website.
- The website will remain up until it runs out in January. Attempts will be made to get results up daily during the Nationals.
- The RV, banquet and stall confirmations are on the website, they were left out of the confirmations mailed.
- There will be a DVD of Ernie Hartnagle's presentation for sale. Let Peter Kontos know if you are attending so he can give the caterers an idea.
- There are 309 reservations for the banquet.
- Volunteers are still appreciated. If there is a profit, then the proceeds will be split among the hosts clubs by percentage of volunteers.
- Even after the Nationals there will be much work still to do.
