I was looking at the last note I wrote for the Nov/Dec 2007 newsletter. At that time Pete asked me to do a retrospective of the previous six years (don't think I really did it), but it did make me wonder how things have changed from when I took office in 2002 to now. So I took a look at the 2002 and 2010 affiliate renewal packages and thought I'd share what I found. In December 2001 there were 242 members, in December 2009 - 213. In 2001 there were 10 conformation shows, 9 obedience shows, 0 tracking events, 7 working trials, 4 agility trials and 2 educational events. In 2009 there were 14 conformation shows, 15 obedience shows, 0 tracking events, 11 working trials, 10 agility trials, and 6 educational events (all stock related). What busy, busy beavers we've all been!!!

I want to take this opportunity to thank MaryAnn and Joe Stoddart for all the work they've done for many, many years hosting the Annual Banquet and keeping stats for the Conformation and Obedience ROM award. The first banquet I remember attending was in Whately (at least I think that's where it was). Whatever restaurant we were at burned down (no, not when we were there!) and I believe the next year they booked the beautiful Log Cabin in Holyoke, where we've been ever since. (Or at least that's my version of ASCNE Banquet history!!)

The search for 2010 Conformation and Obedience ROM coordinator(s) is on. The same person does not have to do both. So if you are interested in either or both venues, please let me know. The Novice A Class is for handlers that have not placed a CD title on a dog from any registry and the dog does not have a CD title from any registry. For the Open A and Utility A classes, your dog must not have earned an Open or Utility title in any registry.

All dogs competing for ASCA Obedience titles are required to start at Novice and work through Utility regardless of Obedience titles awarded by other Registries. ASCA Obedience judges may not enter or handle in the A classes.

All dogs must have an individual ASCA registration or LEP number or an ASCA tracking number to compete in ASCA sanctioned Obedience Trials.

A dog will be allowed to be shown at the trial where the handler applies for an ASCA tracking number. The handler will be issued a receipt by the Registration table valid for sixty (60) days to allow the Business Office time to issue the tracking number. Photo copies or originals of registration or tracking number papers must be presented to the Registration Table upon request when entering ASCA sanctioned Obedience Trials. #### SOME MOTEL COURTESIES TO OBSERVE:

Cover the motel's bedding with a sheet, whether or not you think your dog will get on the bed.

If you crate your dog, please bring a towel to put under the crate to keep marks off the rug. Bring a towel to put under your dog's food dish.

Make every effort to have your dog free of fleas BEFORE arriving.

All poop must be picked up, bagged, and disposed of properly by the dog's handler. The Event Committee will excuse competitors who fail to pick up after their dogs at the test site or the motel. Don't leave your dog unattended. If you must leave, take them with you.

2. To use only individuals who are free from serious hereditary or congenital defects and screening breeding stock for hip dysplasia and ocular deformities.

3. To maintain the best possible standards of health for my animals through regular veterinary care and sanitary housing.

4. As a stud owner, I will refuse any mating which I do not consider in the best interest of the breed.I will screen the healthy, mature bitches sent to me, for hereditary defects and temperament faults.5. As a bitch owner, I will properly space litters and protect bitches from unplanned breeding. To

produce puppies when I have the time and facilities to provide adequate attention to physical and emotional needs of the litter.

6. I will not sell or consign puppies to pet shops or commercial operators. I will not supply puppies for raffles or as prizes.

7. I will be discriminating in the sale of my puppies, keeping in mind the Australian shepherd herding temperament and guardian instinct. I will provide buyers with information about the breed, ASCA and ASCNE activities, pedigree, health records, application for registration and spay/neuter contracts for pet quality puppies. I will monitor and enforce such contracts. I will be available to assist my buyers should they have any questions concerning their puppy.

8. I agree to take back any of my dogs that is in need of a new home or to assist in placement of that dog.

9. I will act to protect the interest of the Australian shepherd breed, conducting myself in a courteous and professional manner in all my dealings.
