President's Note

Hi Everyone -

Dang, it's early May and I thought that meant spring, but it was so cold around here the other night that I'm regretting putting the down comforter away for the summer!!

I went up to Webster, NH, the end of April for the Betty Williams stock clinic. I found watching her with the dogs and the stock very interesting. She has as much concern for the stock and how they're being treated as for the dogs; the stock isn't just a tool for training. Her quiet manner and innate sense of knowing where to be to move stock calmly was great. On Sunday morning (as part of the review of what was done on Saturday) she talked about the importance of the journey we're taking with these dogs, to appreciate the small, medium, and large accomplishments along the way, and to give young dogs time to mature. Getting titles are good for our egos, but our dogs don't care - they just want to be doing things with us.

I think I've been able to do that with my dogs in the agility arena – it's only taken about 15 years though!! When I first started with Zack 18 years ago, it was all about getting the qualifying legs, tracking each one, and earning the titles. I didn't like ugly runs, but if there was a qualifying ribbon at the end, that was the main thing. When there were mistakes, I looked at him and wondered what ever possessed him to do those things. I'm finding now that what really gives me the rush is the smooth run, the difficult sequence done flawlessly, being in synch, working together, getting information out early enough so my dog knows in what direction they should be moving. That doesn't mean I'm not interested in qualifying runs or getting titles, but that's the deciding factor on whether or not I'm happy with a run.

I'll leave my thoughts on how I'm doing with stock for another time (and believe me, that's not because I'm focused on qualifying legs or titles!!!!!)

Canine Health Clinic

In conjunction with the club meeting on July 11th, we will hold our third annual Canine Health Clinic. The health clinic starts immediately after the meeting so we hope that you will attend both!

We will offer the gene mutation test for hereditary cataracts. The test kits must be ordered from England a month in advance, so if you want to do this test, please contact Sheila Dolan at ShezDolan@aol.com no later than June 10. The cost will be \$99.79 for the 19 dogs tested, or if we have 20 or more dogs, \$79.83.

Effective January 1, 2010, any sire or any dam that has produced one litter must have a DNA profile from an ASCA approved lab on file before any subsequent litter registration application is approved. Effective January 1, 2011, all sires and dams must be DNA profiled with an ASCA approved laboratory prior to the registration of their first litter. In addition to the cataract screening and the DNA testing, we will also have an eye clinic and MDR-1 testing available. For all of the clinics you must register and pay in advance. ASCNE members will receive a 20% discount on the CERF, DNA and MDR1 tests for a maximum of two dogs per year. More information will follow. The clinic information and registration form will be posted on the ASCNE website, including pricing, when all the details have been ironed out.
