ASCNE Affiliate Report for 11/7/2010

Committee reports:

Agility- The committee has increased the sanctioning timeline for an agility trial to 60 days before the trial, effective August 1st, 2010 for all trials sanctioned after October 1st. The change will allow judges more time to design courses and will give reviewers a better chance to look them over. The affiliate must provide the judge an equipment list and site description 60 days before the trial. The judge of record then has at least 30 days to design

courses and then must send the courses to the course reviewer 30 days prior to the trial. They are also asking that the judge send a final copy of any amended courses back to the reviewer at least 7 days prior so that the club will have a complete set of the final courses in case of an emergency judge substitution.

Conformation- They have been working on a fix for the hiring of Finals judges so that people who are campaigning a dog can know in advance of the show year who the Finals judges will be. They are also looking at how the Stock Dog Finals judges are chosen as perhaps a model to work with.

They received two directives from the Board of Directors. The first as to allow Non-Regular judges to solicit assignments. In response they haves sent a motion to the BOD to reaffirm the current policy against solicitation with suggestions how to assist Non-Regular judges without allowing solicitation. The second directive was to state that Judges cannot excuse a dog from the ring unless it is covered in the rules. Addressing that is their next item for business. There is a motion on the floor so that the Judge's Code of Ethics are no longer suggestions but instead are enforceable.

DNA- They thank the membership for getting their dogs DNAed before the deadlines.

Education- They have been busy producing informative documents for the ASCA website. They have completed an ASCA FAQ and a Health Information Sheet, as well as some instructional handouts on filling out entry forms. They are in the final stages of creating an ASCA Obedience flyer which should appear soon on the website.

Hall of Fame, Legislative, MVA, Nationals & Strategic Planning- No report.

Health and Genetics- Funds within the ASCA Foundation are proposed to be reallocated for underwriting the registration of DNA samples to the Canine Health Information Center Database. They are just waiting on approval from the donors.

History - The History Committee is now up and running with Jeanne Joy Hartnagle as Committee Chair and Tenley Dexter as Board Liaison, as well as several other members. Among their goals and objectives is to centralize and consolidate historical data and images of the Australian Shepherd and ASCA.

Juniors- They are excited about the educational events they were having at the Texas Nationals.

Obedience- No report.

Rally- Clubs are reporting great success with trials in the new Rally program and many report filled entries.

Stock dog- They welcome member input.

Tracking- They are currently discussing expanding the titles to more closely resemble other ASCA performance events. The downside to the expansion is that most tracking trials fill as it is and it will be frustrating for members to find enough venues to complete these titles.




