The ASCA Board of Directors has a new president, our own Pete Dolan, who I believe will take the Board and ASCA in the right direction. Congratulations, Pete, and I recommend that anyone who has not read his letter from the president in the latest Aussie Times, should.

A motion to create an ASCA Lifetime Achievement Award was approved and granted to Dr. Robert and Lucille Kline. Their foundational Coppertone kennel is in the ancestry of many of the Aussies of today. Dr. Kline also chaired the committee that wrote the first breed standard for the Australian Shepherd.

I will go over the highlights of the ASCA Committee Reports More detailed information can be found in the reports themselves starting on page 22 in the January/February issue of the Aussie Times.

Agility- There has been a rule change regarding bypassing the last obstacle on a course. In the past, if the dog ran past the obstacle, but not over it, there was a 20 point fault. The new rule reads as follows: 8.3.2 If the dog crosses the start line but bypasses the first obstacle, time will begin. However, if the dog bypasses the last obstacle, time shall not end until he completes the last obstacle and then crosses the finish line. If the dog never completes the last obstacle, he shall receive a 20 point fault (for failure to complete) and receive an NT (no time) as his course time. For all classes, if the dog bypasses the last obstacle, but the handler calls him back to complete it, then it shall only be considered a waste of time and no faults shall be incurred.

Another rule change is that all jumps must have 4" jump cups, the crossing of bars placed at 8" is no longer allowed.

Conformation- The conformation committee has several motions before the board right now. They concern their committee's voting schedule, judge solicitation, judge evaluation forms, non regular breeder judge requirements and excusals of dogs from the ring.

DNA- The National Blood Draw collected 44 DNA sample in Waco last fall. The Committee would like to thank all those who had the DNA done on their breeding stock before the January 1st, 2011 deadline.

No reports published for Education, Hall of Fame, Health and Genetics, Legislative, MVA, Nationals, Obedience, and Strategic Planning

Juniors- The Junior activities at the 2010 Nationals were a great success and they are already planning their 2011 activities. They would like input from the membership as to what activities they would like to see at Nationals for juniors that are not currently being provided.

Rally- The Rally Committee would like to feedback on how the trials are going. From the clubs they are interested in the paperwork process, the smoothness of the trials, from the judges, about the scores given and how well prepared the clubs and exhibitors were, and from the exhibitors on the courses, the trial organization and how much fun was had.

The committee is working on additions to the Rulebook, such as Merit Standings, Finals and Championship requirements.

Stockdog- There have been some updates to the Stockdog Rules regarding trials that allow the Started classes to run courses A/B and the Open and Advanced to run courses C/D, and some changes to the C course as to length of arena, the chute and handler lines.

The ASCA Board of Directors presented a directive to the Committee to develop a plan that would have the Stock Finals Budget at net zero, The plan has been developed and sent to the Board.

Tracking- The Tracking Committee congratulated ASCNE and WASCUNY for mounting the first TDU tests.

The Committee is trying to grow the program but realize that the nature of the tests result in high expenses and not enough income because they can only process a set number of tests at a trial. Their report brings up many good questions that they would like to have feedback on. The report can be found on page 24 of the Jan/Feb AT.
