### Directions to Canine Mastery From Rt.95 South of Attleboro

Take Exit 2A (Newport Ave.) to the 2nd light. Take that left onto Benefit St. At the next light bear left onto Central Ave. to the end. Take a left onto Rt. 152 (Newman Ave.) Go ½ mile and take a left onto Pond St. Watch for the Orion Industrial Park on your left (2/10 mile). Turn into the park, we are the second building on the left.

### From Rt.95 North of Attleboro

From Rt. 95 North of Attleboro: Take Exit 3A Rt. 123. ### Affiliate Report – Anne St. Pierre November 4, 2012 (meeting in NH)

### No other motions accessible from the ASCA site at this time or in the past 45 days, except the following: OBFDIENCE

A motion to discontinue the veterans classes was approved, and will take effect 6/1/2013. All veterans shall be allowed at the option of their handler to jump 4" lower than their regular jump height in the applicable division (A or B) of the open class of choice (ODX or CDX) and applicable division (A or B) of the utility class. All dogs entered in the open and utility classes shall be allowed to compete and qualify for placements, high combined, high in trial, merits and finals.

The Business Office shall be directed on 6/1/2013 to transfer any legs earned in veterans on 5/31/2013 and earlier to the applicable class division of A (does not have the title earned yet) or B (has earned the title).

ASCA's regular obedience titles will be: CD, ODX, CDX, UD, and UDX. The rulebook areas dealing with veterans will be brought current by the Committee timely so that the 6/1/2013 rulebook is consistent. The ASCA Obedience Committee presently has open and utility drafts in progress.

RATIONALE: As reported by the Business Office: "We only have 6 dogs that have legs for CDX-V that do not have a CDX title. We only have 4 dogs that have legs for UD-V that do not have a UD title." Feedback to the Committee is that there has been a lack of interest and support in the veterans' classes as they are now in the rulebook. Further, putting veterans back into the A/B classes of open and utility will save money.

  - Pete said it was very good and informative
- October 12-14 Harvest Moon Mania Westfield, MA Peter Kontos
  - Financials
    - Anne suggested doing a raffle to help fund prizes for all the events; needs to be equitable across all venues
    - Pete noted that previously various shows used to do sponsorships (like what is done for Nationals) and that it's been left to the show chairs on how they want to handle their events
    - Jean suggested Anne develop a proposal and bring it to the membership
  - Stress of running in multiple venues
    - Carol said it was discouraging doing MVA at HMM and if ASCNE truly wanted to support MVA then the club should be more accommodating to hold classes or to allow run order changes to be more flexible
    - Jean noted the issue is the same for any handler who has entered their dog in multiple events, not just MVA. She also questioned how long do you hold a class, how many times do you hold a class for conflicts, is there enough daylight to be holding classes?
    - Pete stated MVA is rigorous, regardless of whether it's done at a local trial or at Nationals. However, it is the exhibitor making the decision on number of dogs to enter, the number of venues to enter, and the number of runs to enter. As such, they should be prepared to deal with the conflicts.
    - Agility can be pretty flexible for changing run order if gate steward doesn't
      accommodate, then escalate to the venue chair then and not after the event. Stock run
      order changes have been restricted to moving to the end of the run order as some
      exhibitors were manipulative about where in the order they'd put themselves based on
      the stock.
    - Walkie talkies were suggested as a way to inform exhibitors they were needed in other venues.



### Australian Shepherd Club of New England Breeder Directory List 2012

As a member in good standing in ASCNE I hereby agree to the following provisions:

- 1. To plan each breeding with the intention of improving the Australian Shepherd Breed Selecting sire and dam for temperament, soundness, health and working ability.
- 2. Using only individuals who are free from serious hereditary or congenital defects. Screening breeding stock for hip dysplasia and ocular deformities.
- 3. Maintain the best possible standards of health for my animals through regular veterinary care and sanitary housing.
- 4. As a stud owner, I will refuse any mating which I do not consider in the best interest of the breed. I will screen the healthy, mature bitches sent to me, for hereditary defects and temperament faults.
- 5. As a bitch owner, I will properly space litters and protect bitches from unplanned matings. To produce puppies when I have the time and facilities to provide adequate attention to physical and emotional needs of the litter.
- 6. I will not sell or consign puppies to pet shops or commercial operators. I will not supply puppies for raffles or as prizes.
- 7. I will be discriminating in the sale of my puppies, keeping in mind the Australian Shepherd herding temperament and guardian instinct. I will provide buyers with information about the breed, pedigree, health records, application for registration, and spay/neuter contracts for pet quality puppies. I will monitor and enforce such contracts.
- 8. I agree to take back any of my dogs that are in need of a new home or to assist in placement of that dog.
- 9. Protect the interest of the Australian Shepherd Breed, conducting myself in a courteous and professional manner in all my dealings.
