Increase Agility Participation – Mike Kurdzo

Mike asked if ASCA is doing anything to attract new people, and if ASCA is not, should

ASCNE do something.

- Lots of discussion no decisions or action items
- Pete Dolan replied with ASCA is not doing anything
- Cindy King asked what the factors are when deciding which shows to enter, e.g., venue, economics, friends attending, judge, site. Reply was any and all of the above, just like any other venue. Cindy also asked what was drawing Aussie people to do other venues instead of ASCA trials and why don't they know about ASCA. Ideas tossed out were limited variety of classes, limited variety of judges.
- Indoor venues are turning into a huge draw discussion around indoor vs. outdoor, costs, different calendars between different venues makes sites unavailable for some years; date conflicts with WASCUNY and other ASCNE shows make it difficult to swap weekends when needed
- Over the course of the last 15 years, agility has grown exponentially and there are typically agility events for at least 2 different venues almost every weekend
- Hooks to get people to try ASCNE: ½ price for pre-novice, free run for first trial, recordkeeping book for first ASCA trial
- Anne Hubbard mentioned as an instructor is there a way to encourage newbies at trials thinks agility as a whole is not encouraging new entries; perhaps include a checkbox on the entry form to identify first ASCA trial and have a welcoming committee. Jean Janotta mentioned that was a great idea, but who was going to volunteer for the welcoming committee as she wasn't willing to take on any more from a show organization perspective – ideas are always forthcoming but the bodies to implement and do are not.
- How to attract younger people?
- Comments on the pre-novice class:
 - from a perception perspective, it was felt the judge of record should judge prenovice (even though the rules do not require it)
 - class orders are being changed day of at some shows and this class seems to be moved a lot, in some instances causing entrants to just leave before their run; changing the order of classes day of should not be allowed
