 - 35 entries for Rally!
 - Agility was full with one ring.
 - From a show scheduling perspective, the Red Roof Inn was very full as there
 was a big dog show at the Eastern States Exposition the same weekend lots of
 HMM people there even though it wasn't the 'host' hotel as it was listed in the
 premium
 - Some agility exhibitors were less than thrilled with Sandra Katzen's personality and said they would not choose to show under her again
 - Issues arose between Mark Gary (Fairgrounds Manager) and ARPH Rep Ken Dwyer. Letter will be going to ARPH indicating ARPH will continue to be invited to ASCNE shows held at the Fairgrounds, but the Dwyers are no longer welcome at this site.
 - Areas for improvement next year
 - Premium: include
 - $\circ \quad \text{ correct information for hotel and potluck;} \\$
 - o rules to be used for MVA
 - MVA: run it per rules specified prior to the event don't change calculations at the event; post ongoing scores in a visible location for participant and spectator viewing and to help increase support for participants; find a way to make the award of MVA a big deal; have a dedicated MVA coordinator responsible for doing scoring; if not going to do it according to identified rules, then don't do it

- November 10 Breed show Seekonk, MA
 - Sanctioned; Sharon Ruppell sent email looking for workers
- o November 16&17 Agility Trial Westborough, MA Joey Mason
 - There are 247 runs on Saturday and 204 on Sunday so far. I do have maybe 50 more entries coming in that I know of, so we will be close to my estimated budget for 500 runs. I sent out some emails asking people to come and lucked out, so those are the ones I'm waiting on. An unexpected USDAA trial popped up in Conn., so we lost some entries to that. Confirmations have gone out to all.
- o 2014 calendar updates / notes
 - March Cattle Clinic with Cindi Hayden
 - Matt looking to change dates from March 29&30 to March 22&23
 - There may be a second cattle clinic in April; tentative dates are April 12
 & 13; not yet determined if this clinic will be an ASCNE sponsored event
 - July 18,19,20 Maine Stock Trial will not be ASCNE sponsored
 - Matt has heard from Laura Hamer that there will be a stock trial in Maine on this weekend, but it will not be an ASCNE sponsored event
 - According to Laura, the Maine group is going to try to start a new ASCA
 affiliate up there (due to the distance and lack of ASCNE memberships
 in their area). If they are able to do that, they will do an ASCA trial. If
 they are not able to put things together by then, they will do an AHBA
 trial as they have already hired Jan Wesen for July.
 - August 9&10 Stock Trial
 - Linc Keiser approached Jean at HMM to ask about having a stock trial at Lynette Millville's in August (as Matt is taking this year off).
 - He was told to submit the request with proposed budget to the Board
 - Discussion points on stock 'stuff'
 - Will there be enough entries to support all the trials? Stock entries fees are not insignificant.
 - Rachel Vest noted at HMM that the high number of entries at HMM is not common in the rest of the country
 - Matt said the remainder of the country has more options for sites to hold events but everyone struggles with getting good stock for trials. New England is fortunate to have safe and consistent stock – sometimes a little too dog broke, as noted by some judges.
 - November 2 meeting
 - Matt offered to host the meeting at his house
 - 2014 Proposed Calendar on website needs to be updated Jean will update and send to Robin.

• Proposal for New Arena at Westfield Fairgrounds – Pete Dolan

- There were discussions at HMM about the potential of building a second large stock arena (225 x 125) in the area currently used for the duck arena. The duck arena would then move to the paddock next to the current arena.
- This would allow
 - more cattle runs, assuming more cattle could be obtained
 - could also be used for the started sheep runs as they are typically judged by a different judge
 - finishing up earlier
- Noted that everything ran very smoothly this year and stock finished quite early (3:30, 4:00, and on Sunday everything was finished and torn down by 4pm)
- Matt noted that if additional stock is obtained from different places that it might increase the need for more 'paddocks' in order to keep the stock separated
- The Fairgrounds would take down the existing sheds (leaving the back up as privacy fence), 2 trees, move a light pole, and straighten out the existing chain link fencing. However, they do not want permanent fencing on either end to accommodate horse trailers for horse shows held at the Fairgrounds.
- Pete is putting together a diagram and cost proposal to submit to the Board for flexible arena ends (panels and posts that would be put up/taken down when needed for a stock trial).
