Summer Stockdog Training Clinic 2013

Sponsored by ASCNE

Dates: August 12, 13, and 14

Clinician: Marti Parrish from Washington State

Marti has been breeding and working Australian Shepherds since the mid 1970's. She is the owner of the ASCA Hall of Fame Kennel, "Justus", home of numerous WTCH recipients. Marti has competed in a variety of stockdog trials and now judges ASCA, AKC, CKC, and AHBE trials. She has been sharing her positive training methods at clinics around the United States, as well as Austria and France.

Location: Riverfare Farm, Webster, NH on August 12 and 13

Riverbank Farm, Salisbury NH on August 14

Time: 8:00am to 5:00pm

Fees: Participant fee for all 3 days: \$375

Two days is \$275 or one day for \$160

Auditors are \$35 per day

All fees include lunch and drinks each day

Livestock: Cattle, sheep, goats, ducks, and geese

The first two days of the clinic will be held at the trial site to allow participants to work through problem areas on the ASCA courses and to gain experience in navigating the various obstacles. Marti will coach handlers and their dogs throughout the day and provide constructive information to help everyone improve.

The third day of the clinic will be held at Riverbank Farm in Salisbury, NH. Wednesday will provide a different venue for the dogs and handlers to work in as well as opportunities to work on "basics" and farm tasks with various livestock.

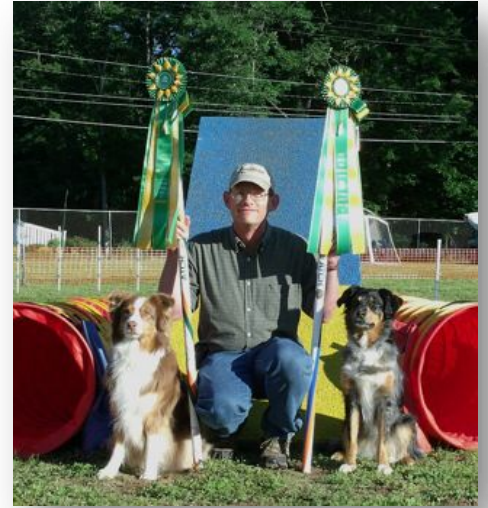

- Pauli asked if there was a breakdown for COS by venue. Jean stated Treasurer's report is high level and that detailed breakdowns can be requested. Pete is traveling but will be asked for one on his return. Initial feedback is Obedience and Rally did very well, agility was down but still in the black.

OBEDIENCE**PLACEMENT: Section 8: DIRECTED OPEN EXERCISES – FOR ODX ONLY.**

Prior to the start of the ODX class, the judge shall measure the radius around the cone and also mark the point over which the cone will be placed. The measuring shall be done as follows: The spot on which the cone will be placed for all teams shall be marked for consistency in placement. Once the cone is placed, the 3' radius for the directed sit shall be determined by measuring 36 inches from outside edge of the base of the cone in each quarter-hour direction (front, back and both sides). The quarter hours on the radius must be marked to allow the judge to more readily discern if the dog has met the requirements. The four foot radius shall also be determined by measuring 48" from the outside edge of the base of the cone and shall be marked as described for the three foot radius. A different color may be used for the three and four foot diameter marks if desired. Chalk or a similar substance may be used for marking. Outdoors, the use of golf tees and similar items is not recommended, but if used, the item must be pushed fully into the ground so that the top is flush with the ground for the safety of the dogs. It is recommended that clubs have a yardstick or other measuring device that can be used.

STOCKDOG

Addition of Stock Dog Champion Title (SDCH)

SDCH awarded to dogs who have completed the following requirements:

- Working Trial Champion-X
- Advanced Farm Trial Dog on cattle and one other stock
- Ranch Trial Dog on sheep and cattle
- Post Advanced Trial Dog on sheep and cattle

Rationale: To develop advanced titles for those who enjoy trialing their dogs in ASCA. If approved it will be incorporated into the January 2014 rulebook.

What Constitutes a Farm Trial

Each sanctioned Farm Trial may consist of any or all of the different combinations of the classes of livestock (cattle, sheep, ducks, and/or mixed).

Rationale: A clarification of what makes a single Farm Trial. Arena trials allow all classes of livestock to be sanctioned as one trial, this addition will avoid inconsistencies in interpretation of what a single Farm Trial is as the SDC Farm Trial review changes membership over time.

Budget deadline requirements in the National Specialty Rulebook from:

From: 12.1 The final budget for the Finals is due at least ninety (90) days prior to the Nationals. Budget must state the number of head of stock to be used in each go-round and final go-round.

To: 12.1 The Host Club shall submit a proposed budget to the Board and Stockdog Committee at least six (6) months prior to the Finals. The budget must state the total number of head of livestock to be used in each class of stock for all go-rounds of Finals. This number should reflect extra livestock on hand to be used in case of injury or illness, with a written breakdown of what is to be considered back-up or extra.

Rationale: This will satisfy the Board Directive issued the Stockdog Committee and bring the budget requirements in line with the other programs within ASCA. This will also allow the Board and Stockdog Committee the opportunity to review and request any necessary changes without creating a hardship on the Host Club. This will be placed in the January 2014 rulebook.

- **2016 Nationals - Email Inquiry from Cherie Soule (PENN-NY ASC) – May 28 - Jean**
 - There are some people from New York talking about hosting the 2016 ASCA Nationals. Cherie has volunteered to be the event coordinator. Initial discussions were to limit hosting to New York clubs. She was considering a recommendation to include all Northeast clubs, including ASCNE, Brandywine and Garden State, but wanted to check with each club on their level of interest before actually making the proposal.
 - Discussion included
 - Insuring the venue chairs were experienced in both the venue as well as budgeting for the venue
 - Would it make more sense to communicate to ASCNE members that if they wanted this to happen to reach out and volunteer as individuals
 - Insuring the entire consortium would work as a team and not splinter into individual venues
 - The overall leader needs to be able to keep all venue leads on task and budget conscious
 - ASCNE's bank account is not at the level it was in 2005 when the planning began for the 2007 Nationals
 - Final decision was more information is needed – how will things be run, what exactly is being asked of ASCNE. Perhaps Cherie could make a presentation or something.
- **Election Year - Jean**
 - This is an ASCNE election year and there are going to be many opportunities for individuals to contribute to the Club.
 - At a minimum, the President, Treasurer, and Affiliate Rep are not seeking re-election
 - A nominating committee will be established around the first of September (one Board Member and two ASCNE members). This committee is tasked with presenting a slate of candidates to the BOD by the first of October. This slate will then be presented at the November membership meeting. Others may be put on the ballot at that time. All this is in the by-law document on the web.
 - If you are interested in running for a position, feel free to check the ASCNE bylaws (on the Members page of the website) or ask an existing Board member about the position.
 - If you're interested in being on the Nominating committee, let Jean know.
 - Terms are two years.
 - Keep in mind all the events that are listed above for 2014 – the Club needs to exist to sanction these events and for the Club to exist, it needs a Board!!
- **Newsletter – Anne St. Pierre**
 - Anne will be stepping down as Newsletter Editor
 - She proposed doing away with the newsletter as all the information is contained elsewhere on the website
 - Jean pointed out that although the Club By-laws don't specifically state the requirement for a newsletter, there might need to be wording changes if the newsletter was no longer published.

Motion to adjourn the meeting by Pauli; seconded by Kathie; motion passed. Meeting adjourned at 3:15pm
