## The Ethical Dog Breeder's Office | by alison smith

The phrase "dog breeder" generally conjures up visions of blissful hours spent playing with adorable puppies, but rarely includes the reality of just how much office work, among other things, is actually involved. As I dug through my overstuffed file cabinets the other day in a hurried search for an old dog's long forgotten hip rating, I decided there has got to be a better way to keep track of kennel related information. In pursuit of success at my New Year's resolution to finally "get organized," I sought out the advice of my fellow breeders. I posed these questions:

Alison is the owner of Paradox Australian Shepherds in western Massachusetts. She is a Hall of Fame Kennel breeder of 20+ years, AKC Breeder of Merit, Canine Good Citizen Evaluator and owner of a small boarding and daycare kennel, The Grinning Dog, LLC. Q. What office, filing and software systems do you have in place for managing the endless paperwork of dog breeding? What have you tried, what works best for you, paper or computer - a mix? Any favorite software or tricks to help stay on top of whose cheek swabs were sent in, who needs a rabies shot, flea preventative or eye clearance next? How do you keep track of microchip numbers, contracts and buyer records?

The responses I received indicate that the majority of breeders use a combination of paper files and digital storage and tracking.

## PAPER BASED SYSTEMS

Good old-fashioned paper files are far and away still the most popular way to keep dog records. Although there does appear to be a shift towards scanning paperwork into easily searchable digital folders, it seems doubtful the file cabinet will be phased out entirely. Here are some examples of the paper-based systems that were shared with me:

"Accordion files for each dog with folders within for registrations, health, heats, litters, etc. all by hand. I keep a single folder for each litter..."

"Three ring binders: One for current dogs and one for past dogs. Each dog has a plastic page sleeve with all pertinent information in it. The front of each protector has a sheet with the dog's name, vaccine info, heat info, etc.

"Subject Binders: Kennel, Medical, Individual dog, Litter, Show, and special interest binders. My favorite is a handwritten spreadsheet from the Litter binder kept over weeks at the whelping pen: names, time of birth, weights, markings, teeth, NBT, & temperaments (huge was early written temperament observations...how constant over time: smart/alert/does not settle, quiet/soft, cute/calm/smart, pissed!)"

"I have a file cabinet where I have marked dates of birth on the main tab folder with sire and dam under that. Then in each hanging folder is a tabbed folder with each puppy and their paperwork. I scan all paperwork into my computer so I have it on file there as well."

"I use a simple alphabetical system for the active dogs and their litters. Inactive/archived files are kept in a dated system in a separate file cabinet"

#### COMPUTER BASED SYSTEMS

Pedfast, a database and pedigree program, was the choice of the majority that used a computer-based system, followed closely by self generated spreadsheets on programs such as Excel, Access and Filemaker/Bento. One breeder links each dog's files directly to its webpage so all clearances are readily available to anyone who's interested.

"I scan everything and have a folder on my desktop. Then I have excel for shots, heats, expenses, registration numbers, shows, points and judges names (with notations)..."

"A folder for each dog on my computer, connected to the terminal (sic) of the dog on my website."

"The data in Filemaker is completely manageable and searchable. You can link it to other files you may currently have as well."

"I use the program Breeder's Standard [now Pedfast], which gives me pedigrees, health records, litter records, championships, addresses of owners of pups, etc. But I also have paper files and other records on computer, such as record of dogs bred, individual medical files and such..."

"I use Excel files and iCal. I have one for puppies/owners, another with many tabs for my income/expenses. For worming, heats, birthdays, vaccinations, etc. I use iCal (Outlook Calendar would probably work as well). If I put in a dog's name on the search it brings up a box of every entry I've ever made with that dogs name on it in date order. I print them out monthly in case of computer glitch. I can input annual/monthly/etc reminders with the date in parenthesis that I first entered that info. Calendars have more user-friendly organizational features than most people know about. Imagine being able to put in a dog's name and have every notation you've ever made come up together. "

"I use NeatDesk to scan and digitally file all my paperwork. You can scan up to 50 sheets at a time (good for archiving), label them and keep them in a virtual, fully searchable file cabinet. You can email files directly from the program."

#### **REMINDERS**

Programs like iCal and Microsoft Outlook work well as a reminder system and are almost ideal for breeders who have so much time and date related information to keep track of. Most have a search feature that allows easy access to historical data (when was she in heat last?) on any dog whose name you've ever noted. Reminders are easy to schedule (eye clearance next November, rabies due on Fluffy, send lease paperwork, etc.) and each "appointment" can have files (directions, registration, contracts) linked to it and notes (bring vaccines, client cell phone) made on it. These systems have possibly the most untapped potential for breeders. Paper calendars are still the trusted stand by for many people, but lack the easy search-ability of digital versions.

## **SAFETY**

Several respondents reported using a fireproof safe to store paper files. Those that depended primarily on digital files used either online backup services like Carbonite or backed up to external hard drives. Many breeders mentioned regularly printing out digitally stored material, in case their computers or servers crashed.

How we organize our offices and shuffle our papers is, of course, quite personal. The best systems seem to combine some form of paper and computerized filing. Easy searching is becoming more and more of a priority as we juggle increasingly onerous amounts of paperwork. Being able to get your hands on that archived hip rating without losing the time to return calls or go for a dog walk can help keep your kennel running efficiently. It means a happier breeder, happier clients and, most importantly, happier dogs. Less stress all around!

It's vital to remember that even as small hobby breeders, we are essentially running a micro business. If we want buyers to opt for us, as opposed to the instant satisfaction of the internet, we must present an organized, reliable and accessible package. Keeping our offices and paperwork running smoothly is just one part of helping reframe the work of ethical dog breeders as reputable and professional.

## The Advantages of Purebred Dog Research | Podcast C.A. Sharp


## **ASGHI NEWS: Samples Needed**

Dr. Patterson's research team at the University of Minnesota has analyzed data from 88 Australian Shepherds, half of whom have epilepsy and half who do not. They have identified areas on three separate chromosomes that may have some relation to epilepsy in the breed. Improved DNA technology will be used to sequence those areas to search for mutations that may play a role in Aussie epilepsy – however, to be able to do so, they need more samples.

Samples from epileptic dogs are especially needed. If you have an Aussie with epilepsy and have not previously submitted a sample to the study, please consider doing so. Your participation is greatly needed and is entirely confidential. This study is our best hope for developing tools that will help breeders avoid producing this terrible disease. Knowing the genetics of Aussie epilepsy may also lead to better treatment for affected dogs. Please, if you have an epileptic dog, send a blood sample.

# Affiliate Rep Report-Anne St Pierre OBEDIENCE CHAPTER I: GENERAL REGULATIONS Section 32: EMERGENCY JUDGE

On the day of the trial, if the judge hired is absent or incapable of judging, the Obedience Chairperson, Obedience Trial Committee or Show Committee shall first ask another obedience judge in attendance to substitute judge. If no other obedience judge is present or willing to be the substitute judge, the officials listed above should hire the individual most experienced in obedience trialing and training.... competitors may request and receive a refund of entry fees if they choose not to show under the emergency judge. New Rule: Effective June 1, 2013.

**CHAPTER 7: OBEDIENCE TRIAL CHAMPION** OTCH: SECTION 3: REQUIREMENTS FOR THE OTCH-O TITLEA total of one hundred (100) points must be earned. Points can only be accumulated after the dog has received a UD title from ASCA. The dog must have (1) score of 193 or higher from ODX Open B, one (1) score of 193 or higher from Utility B, and one (1) score of 195 or higher from either ODX Open B or Utility B. Only scores from ODX Open B and Utility B will qualify a dog for the OTCH-O title. Any dog that has met the qualification requirements for the OTCH-O will receive a certificate for the title and will be allowed to use the prefix "OTCH-O" before the name of qualified dog. Each additional time a dog is awarded the title of OTCH-O, the applicable number following the title may be added (such, as OTCH-O2, OTCH-O3, and so forth. Scores of 185 or lower will not earn points towards an OTCH or OTCH-O title

# AGILITY: Motion 11-2012 Junior Handler Division - Qualifications for Finals 11.2.4 Minimum Points

For all divisions, a dog will need at least 7 points total to be eligible to compete at the Agility Finals. A minimum of 2 points must be earned in the Elite Jumpers class and a minimum of 2 points must be earned in the Elite Gamblers class and a minimum of 3 points must be earned in the Elite Regular class in the Standard or Veterans or Junior Handler division, during the qualifying period. Points must be earned during the ASCA Agility Finals qualifying period and within the same division that the dog will enter at Finals.

## Section 6 - Protests and Complaints 6.1 Rule Infractions - At Trials

Exhibitors witnessing rule infractions or violations of the Judges Code of Ethics shall notify the Trial Chairperson or Trial Committee of any violations. The Trial Chairperson will be responsible for discreetly and tactfully discussing the complaint/rule infraction with the judge in a timely manner to avoid any further rule infractions during the remainder of the trial. Any judge refusing to comply with the rules after being notified by Trial Chair/Committee shall be reported on the club's Judges' Conduct. Evaluation Form and the incident will be investigated by the Agility Committee.

### 6.1.1 Trial Reports

General comments and impressions of judges can be submitted by the host club using the Judges' Conduct

Evaluation Form. The Business Office will forward comments on a judge's performance to the Agility Committee for review. Multiple negative comments may be forwarded to the Board of Directors for possible suspension of judging privileges

**6.2.1** Timely submission of courses and/or trial reports. Judges who fail to comply with the timelines for course review and trial reports will be sent warnings of the infraction(s) via email by the ASCA Agility Trial Chair. Repeated (more than two or three incidents) failure to comply with the guidelines will be reported (with documentation included) to the ASCA Board of Directors for possible suspension of judging privileges.

#### 6.2.2 Rule infractions - Post Trials

Incidents of rule infractions should always be brought the judges attention at the trial by the Trial Chair or Trial Committee. Incidents of rule infractions/violations after the trial has ended may be submitted to the Business Office or the Agility Committee. Critical rule violations will be investigated and the judge will be contacted to discuss the incident by the Agility Committee Chair. Repeated (two or more incidents at subsequent trials) violation of rules by the Judge will be reported to the Board of Directors for possible suspension of judging privileges.

## **6.3 Formal Complaints**

Exhibitors may file a formal complaint of any rule violations made by an Agility Judge to the Board of Directors for investigation. Complaints shall be submitted to the Executive Secretary, pursuant to Section 1.1.2 of Appendix G - ASCA Dispute Rules. If the complaint is valid, the judge may be reprimanded, suspended, or have judging privileges revoked by the Board of Directors

#### **MVA EVALUATOR**

**5A.** The individual must be an ASCA breeder judge; **5B.** must apply to be an MVA evaluator; **5C.** Trialed Aussies on cattle or sheep; Or worked Aussies on their farm or ranch, Or have worked at a stock trial as course director, timer, or stock handler. **Comments:** The intent of the rule change around judge selection is the committee's attempt to make the MVA Evaluation is a level playing field for all dogs competing.

Anne St Pierre is the new newsletter editor succeeding Robin Goodman who has stepped down. Show Premiums vs. Approved Premiums-ASCA approved premiums are posted on the official ASCA website. Any changes to show premiums by the affiliate club cannot be made unless approved first by the ASCA business office.

Robin Goodman sends out a copy of the show flier to the show chairs of that show for their perusal (1 week) at which point she send it to the Show Coordinator (Susan Winters) who in turn sends it along with the sanctioning form to ASCA for sanctioning. Usually most fliers state "sanctioning pending."

Newsletter distribution- Robin sends a PDF file to Dottie who forwards it to member email addresses (electronic newsletter). Robin Goodman suggested that she can post the newsletter on an unpublicized site on the ASCNE website. When Anne St Pierre creates the PDF newsletter, she will put it up on the website. Anne also brought up a program that would cost the club 25.00 a month to maintain called the "Wild Apricot". It manages membership files, newsletter, passwords, electronic payments i.e. Paypal, etc. The website we use now is 55 dollars for the whole year along with a minimal domain charge. Anne St Pierre brought up the MVA class at last Harvest Moon Mania - specifically say that there were conflicts that involved stock, agility, obedience and rally. Joey Mason suggested buying a radio system so show chairs of each venue could talk to each other when there is a looming conflict. Pete Dolan said that MVA participants must enter stock and conformation evaluation. They have a choice whether to enter rally, obedience and agility. If an individual wants to enter "everything" that

is their choice. The "extra" entry money is for the conformation evaluation. If you don't run in turn in stock you have the option to run at the end of the class. Agility offers the magic "c" next to your entry number designating a "conflict" and they can accommodate that person. It is difficult to do MVA but doable. If there are realistic avenues to alleviate the stress and make it easier on the entrant so be it, per Pete Dolan.

Robin Goodman brought up a think tank "lessons learned" adopted from her place of work. All the show chairs from the HMM show or whatever show offering MVA should get together and brainstorm right after the event to figure what worked, didn't work and how to fix it for the next time. Then get together ahead of the event, refresh issues, thus work things out ahead of time. This has been relayed to Peter Kontos to apply to his show chairs for the HMM 2013 with hopes of diverting future MVA issues if at all possible.
