The motion to accept the Treasurer's Report was made by Lee Prager, seconded by Kate Viles. Motion passed.

Affiliate Report: Pauli Haggis presented the Affiliate Report:

I apologize that this meeting's report is incomplete. For the past 3 weeks I have been trying to access the Current and Past motions of the various program committees on the ASCA website. The site won't open, so I was not able to retrieve the most recent activities of the ASCA BOD. I asked a few other club members try to open the files and they were also unsuccessful.

Of particular interest to the ASCNE members, are the outcomes of

- I: The agility committee's motion to discontinue offering a Veteran Handler Division; which was voted down.
- 2: The Rally committee sent the BOD a motion to allow praise at the end of each task at the Masters Level. This motion was passed.

The only program information I could access was from the stockdog committee.

Motions from the stockdog committee and passed by the ASCA BOD include:

- I: No competing dogs may enter the trial arena or holding pens except during their run. A non-competing dog may be used in the pens to move stock at the discretion of the judge and/or Course Director. A trial is considered to have concluded when awards/ scoresheets have been presented. At the conclusion of a trial the trial arena can be used for other stock events such as jackpots, clinics, lessons, and demonstrations with the approval of the judge, course director, and stock owner.
- 2: Open and Advanced Farm Trial competitors need a minimum score of 70% of the total points offered to qualify (90 of 130 points). They also must at least make an attempt at each element of each task to qualify, regardless of total points earned. Tasks must include 6 categories: gather, sort, pen work, chute and 2 location specific tasks. Tasks that are divided into separate segments would require an attempt at each segment to achieve a qualifying score.
- 3: Since many clubs have trouble finding sufficient workers, trials are no longer required to have 2 timekeepers per arena. There will now be a minimum of 1 scorekeeper/timer who will be responsible for tallying points on the scoresheet and operating 2 stop watches.
- 4: The stock dog committee is clarifying judges duties and developing a guideline in table format describing general offenses, infractions, and reinstatement policies.

Library Report: No report.

Newsletter Report: Art Landry stated that submission deadline for the next newsletter is November 15th.

BOD Report: ASCA Board member Cindy King was present. She announced that Matt Mason is the new Stockdog Committee member representing our area. She also shared that the DNA contract has been renewed for five years, but there will be an increase of \$1 in the price of a kit. Lastly, there have been issues associated with non ASCA agility clubs holding ASCA events. These issues will need to be addressed or this program will be discontinued.

Harvest Moon Mania 2015: After much discussion of possible other dates to hold it since it's current date conflicts with the Nationals in Tennessee, the majority of the members present were in favor of not having it at all. Agility may look into holding a 3 day agility trial with NY in September at Westfield, MA or Washington County, NY.

Nationals conformation pre-show: Members felt they needed more info and to get a sense of how many volunteers they would need/could get.

2015 Calendar: A motion was made by Art Landry and seconded by Karen Souza to allow Rally and Obedience to take over the February 7th & 8th date from conformation. Motion passed.

Conformation ROM: A committee of five has formed to address the award duplication: Karen Souza, Gull Gullicksen, Kathy Choiunard, Sue Winters and Nancy Gagnon.

New Business:

No new membership applications.

A member questioned if the ACE classes would count toward our ROM special awards. They will not count this year.

Skype meetings for BOD: In order to hold meetings via Skype, a change would have to be made in the ASCNE bylaws, and that change would have to be approved by ASCA.

Art Landry made the following motion:

"I make a motion to ask the general membership to approve adding the following section C to the ASCNE bylaws as indicated below:

Add section 4.2.2. C to the following

4.2.2. The Board shall meet not less than six times yearly to conduct business of the Club. Special meetings of the Board may be called by the President at any time, with 15 days' notice to the members of the Board.

A. A quorum shall consist of 4 Directors. The presence of a quorum is necessary for all voting. Unless otherwise specified in these Bylaws, any matter may be passed by the Board of Directors by a simple majority of those Directors present to vote.

B. All meetings of the Board of Directors may be attended by the general membership except when it is considering matters of discipline. When considering matters of discipline, only members of the Board and the person whose conduct is in question may be present.

C. Board meetings may be held in person or by audio, video or audio-video conferences either by phone or by internet means at the discretion of the Board so long as sections 4.2.2.A and B are followed."

I further move to change

"Section 5.4. Votes of the Board of Directors may be taken by any of the following methods: telephone, e-mail, U.S. mail, fax, or in person."

to

Section 5.4. Votes of the Board of Directors may be taken by any of the following methods: internet or telephone conferencing, telephone, e-mail, U.S. mail, fax, or in person." "

A suggestion was made to change "or in person" at the end of section 5.4 to read "and/or in person" to allow for votes to be taken both in person and electronically at the same meeting. This suggestion was passed as an amendment and the motion as amended was passed.

Carol Landry was appointed the new Stockdog Coordinator.

Next Meeting will be a General Membership Meeting January 4th at Canine Mastery, Seekonk.

Cindy King would like to hold an event for juniors in the spring. She was encouraged to explore the possibilities.

Motion to adjourn was made by Kathy Chouinard and seconded by Karen Souza. Meeting adjourned at 2:15 PM.

Legislative

The KODA lawsuit to oppose implementation by the USDA to license and control breeders who have 4 or more intact females has failed. The when and how they intend to enforce the licensure act is uncertain, so breeders, especially if they sell and ship pups to buyers sight unseen, are encouraged to get licensed and review the restrictions imposed by the USDA.

Stock Dog

Changes/clarifications in the stock dog program are primarily aimed at clarification of procedures for running the Finals. They include time-lines/guidelines for submission of budgets, submission of receipts for reimbursement, minimum number of workers and positions which need to be filled, and a list of supplies to be supplied by the host club. For a complete description you should consult the ASCA website. Of interest to Course Directors and competitors; for courses D + F, the location of Obstacle I will always correspond with the Advanced handlers line. This will accommodate arenas of varying shapes/dimensions.

Obedience

For Obedience Finals, there is a clarification that Bitches in Season will run last and must wear pants.

Beginner Novice is to include a walk through without the dog of the healing pattern for both B and A divisions. The judge is to be present to point out the direction of the pattern and answer questions. The walk through is expected to last 10 minutes.

BOD Protocol

If rule changes in a particular program concern you, please be advised that you have a voice. The ASCA BOD posted the protocol for considering motions forwarded to them by the program committees. The program board liaison reports committee recommendations to the Executive Secretary as a proposed motion. The BOD then discusses the motion. At that time, the Executive Secretary posts the proposal to the membership on ASCA-L and the ASCA website for member comments. Members are to send their comments/concerns to the Executive Secretary by the 15th of the month. The BOD then reviews the feedback and makes its final decision.

The other recent post by ASCA to the membership is an outline of the protocol for filing a complaint. The primary change made by the BOD is to provide an option whereby they can authorize a reimbursement of the filing fee if they find in favor of the complainant. This post is especially noteworthy to ASCNE as your BOD recently had to decline handling a complaint because it was filed inappropriately. Please know that if you feel that someone has put you or your dogs at risk, or has directly interfered with your ability to participate at an ASCNE event, you do have recourse. As an Affiliate of ASCA, we <u>must honor ASCA</u>'s protocol in the filing of a formal complaint: to the letter. So, before you take pen in hand, please review the dispute rules on the ASCA website under ASCA information, governing docs. and follow proper protocol.

Library Report: Carolyn Rancourt was unable to attend the meeting, no report. Pete Dolan brought a contribution for the library.

Newsletter Report: Art Landry stated that submission deadline for the next newsletter is January 15th.

BOD Report: Pete Dolan shared with the members that ASCA committees have from the Ist to the I0th of the month to submit a motion and it is posted for comment and then the BOD reviews it. Unfortunately it seems that the current BOD supports committees without regard to the business and/or financial end of the motion. He recommends that the general membership should take note of motions and put some effort into commenting on them.

Karen Souza presented the findings of the Conformation ROM Committee:

Conformation ROM Review Committee Recommendations

1/4/15

Committee members: Karen Souza, Kathie Chouinard, Nancy Gagnon, Gull Gullicksen, Susan Winters

The Conformation ROM Review Committee proposes the following updates to the current rules. The purpose of the changes is to differentiate Class and Winners awards. The categories current similarities have resulted in a very large percent (95%) of dogs winning both awards.

During our discussions we also decided to keep ROM ribbons for both Class and Winners.

The proposed changes include:

- 1. Returning Best of Winners to Class Award.
- 2. Removing Reserve WD/WB form Winners Award.
- 3. Adding Best Opposite to Winners Award.
- 4. Adding Best of Breed to Winners Award.

During our email discussion another issue came up. The committee feels that the ROM forms should be done on an honor system (no judge signature). Others clubs have already started doing this.

Class - Bitch and Dog

- I point for each dog defeated.
- Winners Dog/Bitch receives the number of points that is equal to the total number of Dogs/Bitches entered in the regular classes minus I (since they did not defeat themselves).
- Reserve receives the number of points that is equivalent to the total number of Dogs/Bitches entered in the regular classes minus 2 (themselves and winners).
- Best of Winners also receives the number of points equivalent to the number of dogs/bitches, (whichever they are not) entered in the regular classes.

Winners - Bitch and Dog

- Only dogs/bitches who go Winners are eligible to earn points in this category. They receive one point for each dog/bitch defeated.
- Best of Winners works the same as in the Class Dog/Bitch category. Best of Winners also receives the number of points equivalent to the number of dogs/bitches, (whichever they are not) entered in the regular classes.
- Best Opposite is awarded one point for each dog or bitch (class and special) of the same sex or total entered of the same sex minus 1.
- Best of Breed is awarded one point for each dog and bitch (class and special) or total number entered minus 1.

Pauli Haggis made the motion to accept the recommendations of the Conformation ROM Committee and Dottie Duclos seconded. Motion passed. Art Landry asked Karen to work with Robin to update the rules on the website and to update the Conformation ROM Form.

within 30 days of the event. Exceptions will be handled on an individual


basis but the Treasurer must be notified before the 30-day limit is reached,





All dogs must have an individual ASCA registration or LEP number or an ASCA tracking number to compete in ASCA sanctioned Obedience Trials.

Effective January 1, 2004: All dogs six (6) months and older must have an individual ASCA registration or LEP number or and ASCA tracking number to compete in ASCA sanctioned Obedience Trials. A dog will be allowed to be shown at the trial where the handler applies for an ASCA tracking number. The handler will be issued a receipt by the Registration table valid for sixty (60) days to allow the Business Office time to issue the tracking number. Photo copies or originals of registration or tracking number papers must be presented to the Registration Table upon request when entering ASCA sanctioned Obedience Trials.
