General Membership Meeting Minutes of Sunday, November 1st, 2015 Janotta Household, Raymond, NH – Carol Landry, Secretary



The meeting was called to order at 12:43 PM.. Board members present: Arthur Landry, Gull Gullicksen, Carol Landry, Pauli Haggis, Michael Kurdzo & (via phone Kathy Buckley). Members present: Lee Prager, Bill Haggis, Barb Barreiro, Robin Goodman, Jen Chase, Beth Adams. Guests present: None

Secretary's Report: A motion was made by Lee Prager and seconded by Pauli Haggis to waive the reading of the minutes from September 13^h. Motion passed. A motion was made by Robin Goodman and seconded by Mike Kurdzo to accept the minutes as published in the ASCNE newsletter. Motion passed.

<u>Treasurer's Report</u>: Kathie Chouinard was unable to attend (her husband recently suffered a heart attack), but she sent along the information that the only change is a deduction for the \$1100.00 balance due on the facility rental for the November Agility trial. New balance is \$25,155.18.

Affiliate Report: Pauli Haggis presented the Affiliate Report:

I attended the Affiliate meeting at the National Specialty. The ASCA BOD wanted to highlight areas of concern to Affiliate Clubs which largely mirror concerns the ASCNE BOD has been working on over the past year.

First is a review of the appropriate format for handling disputes. The dispute process is published in the ASCA rulebook, and the rulebook is to be present at all ASCA shows and trials. However, it may be prudent to direct all show/trial chairs to that section of the rulebook prior to an event so they are familiar with the proper procedure in handling a dispute. Since any ASCNE officer/BOD member on site may be called on to implement proper procedure, they should also be familiar with the protocol as well as having copies of the ASCA complaint form available for use.

ASCA also provided a checklist for paperwork that needs to be filed within 15 days of the completion of an event with a reminder that Affiliates are responsible for storing copies of all event entries and results for 1 year.

It was also suggested that Affiliates maintain their own insurance and sanctioning packets will include a request for ASCA insurance coverage in the future.

A copy of the conformation Judge's code of ethics and a copy of the Judge's Explanation form for excusing/disqualifying a dog from competition was also provided.

The affiliate representatives present discussed problems they would like ASCA to review and resolve. These included an update of the ASCA judges lists, since several clubs had tried to hire judges who are no longer active and several who have passed away; a source of discomfort for both the show chair and the family of the deceased. There were also a few complaints over multiple Affiliate Clubs being chartered within the same geographical area which is causing some problems with show dates/sanctioning.

The following motions have been voted on by the ASCA BOD:

Agility

I: The Agility committee worked on a format to run an **all-breed ASCA Agility Finals**. The proposal failed to pass the ASCA BOD in its current state with some BOD members encouraging the committee to continue work on the concept. It failed largely because ASCA is a breed/not performance organization. It was of further concern that this would open the door for other performance programs (stock/ obedience/rally) to want similar programs

The ATCH invitation to Finals will be discontinued. All Finals competitors must earn a spot based on points accumulated during ASCA trials from 5/31 to 6/1 of the year preceding the Finals competition. All alternates will be notified of their point ranking and will be invited in order of rank until all slots are filled. They must fill out an entry by July 15th and will be notified if/when they get a spot.
 Veteran Handler Division: the inclusion of a Veteran Handler Division based on age of the Handler was voted down.

4: **Cancelled trial dates.** In the event an ASCA Agility trial is cancelled after being sanctioned but before the trial date, the ASCA office must be notified immediately. Sanctioning fees may be transferred to a future trial date. The responsible club must reimburse a judge for any non-refundable expenses that have been incurred that cannot be transferred to a future date. the ASCA office will notify the judge and course reviewers that the trial has been cancelled.

Rescue Grants:



Grants will be available to rescue organizations that primarily rescue Australian Shepherds in increments of \$5,000.00. The ASCA Foundation Board is to form a committee of 3 ASCA BOD members to review grant applications. The review is to be completed within 60 days. Applications for grants can be obtained from the ASCA Business Office, the Executive Secretary, or on the ASCA website. Once approved the ASCA Business Office will remit the funds to the approved organization. Grants will be limited to one grant per year.

Insurance

Art read through an email he received from Wendy Richmond concerning our club's insurance coverage.

"Hi, I read through the policy and here's my thoughts. It's a pretty standard General Liability policy, with a few changes/additions to tailor it for dog clubs. We've got coverage for 30 "cow panels" and the 2 40x50 pvc obedience rings specifically scheduled, plus the policy states that it offers \$5,000 of "misc equipment", all with a \$250 deductible and "All Risk", Replacement cost. Get to buy same stuff, new -good deal! Misc equip to me means items like the agility boxes and contents, whatever else the club has for small equipment. One thing it does not cover is "missing items" - if we got to Westfield and some of the panels, or ring gates are missing but there's no evidence of a break-in or foul play, the stuff is just gone.

Liability limit is standard, \$1 mil per occurrence, \$2 mil max for the year. It also extends "Insured" status to all club members, volunteers, judges and committee members, as long as in the course of club activities. Executive officers and directors are covered for the scope of duties for the club, but I would recommend getting a quote for Directors and Officers coverage, see what the premium is. This premium is great, Sportsman's Club has been writing for dog clubs for ages so has pretty much everything covered.

If any show location requests to be added as Additional Insured, there is a \$50 fee for each addition. Seems like most places just want to see proof of coverage. That's all I could see, looks like a good solid policy and worth it for the club to keep.

It was decided that we are carrying adequate coverage but we might still explore coverage for Officers and Directors of the club.

The 2015 Shelbyville, TN, ASCA National Specialty was our first Aussie Nationals. I attended with both of my dogs, Jacob and Skye. We entered ASCA Rally for the first time at the ASCSFL Preshow and at Nationals. Both dogs qualified with scores of 191 in the morning trial at the preshow. In the afternoon, both dogs earned X qualifying scores with Skye earning a 197 and Jacob earning a 196. At Nationals, they both earned X qualifying scores of 197 and gained their ASCA Rally Novice titles. Both dogs also competed in Agility Nationals, but we had a bit of a rough time due to my sprained ankle. Skye earned a third place qualifying score in Novice Jumpers and a first place qualifying score in Novice A Regular (her first ASCA Agility Qs). We also took a side trip to Cartersville, GA, to compete in USDDN (disc dog) World Finals, where I also judged. I was pleased with how well both dogs handled the extensive travel and competition in the largest venues that they've ever seen. We look forward to our next chance to attend Nationals.




Gidget had a spectacular Nationals!


