# Multiple events on a weekend

Lately we have had multiple ASCNE events scheduled for the same weekend. While there is nothing in writing that precludes it, we should try to avoid it when possible. When a second event wants to happen on the same dates already taken, the original event should be notified for their input.

A similar situation is three agility trials in four weekends, as we have scheduled for May and June of 2017. This could create a potential conflict and the outcome will be revisited at the July meeting when the calendar is set for the following year.

#### Stock at HMM

Lee says it continues to be a difficult job having a stock trial at the fairgrounds. The amount of work for set up and tear down is extensive. Suggestions were: hire Mark and he finds help to do it (adding the extra cost to entry fees), free runs for major helpers (as agility does), or no stock trial. If there is going to be stock at HMM 2017, a Course Director is needed (or better yet, two co-directors). Someone needs to step forward by January 1, or cancelling stock at HMM will be discussed at the Jan meeting.

Mary Ann asked about the "private event" sign at the fairgrounds. She thought it kept people from coming in to see the show. We don't know if it is an insurance issue for the fairgrounds. Perhaps a "welcome ASCNE" sign could be put up.

Mark asked Lee about changing the dates of HMM to accommodate the AKC trial. Pete Dolan proposed we move HMM to the weekend of 10/13-15/17. Linda Barden seconded, motion approved.

A \$470 donation to ASHGI was raised at HMM from Judi Schachte's raffle.

Meeting was adjourned 1:40pm.

#### Addendum

We found out after the meeting that Pauli Haggis was absent because she had a brain stem stroke the night before. At the time of this writing Pauli is in rehab and although it is slow she continues to make progress.
