#### From Rte 95 North of Attleboro, MA:

Take Exit 3B/Rte 123. After fire station take left onto Read St. Follow to stop sign, turn right and immediate left onto Read St. (There are signs for the animal shelter) Take 2nd right onto Pond St. Watch for Orion Industrial Park on right (3/10 mile). Turn into park, second building on left.

#### From Rte 195 East or West:

Take Massachusetts Exit 1. Follow 114A North. In approximately one mile you will reach a fork in the road, bear right (Grist Mill restaurant is on your left). This is Arcade St. You will come to intersection of Rte 44. Go straight across and continue on Arcade to the end. This is junction of Rte 152. Take a right onto 152 North / Newman Ave. Follow for about 5 miles to intersection of Central Ave (after Rojacks). Go 1/2 mile and take left onto Pond St. Watch for Orion Industrial Park on left. Turn into park, second building on left.

Jacob earned his ARCHMX (Rally Master Champion) in WCRL Rally at the Monadnock Humane Society on October 1, 2017.









# **MEETING MINUTES:**

Minutes from the November 5, 2017 meeting Pawsitive Kinection, Grantham, NH

Meeting was called to order at 12:21pm

Attendance: Kathie Chouinard, Gull Gullicksen, Anne Hubbard, Kate Viles, Matt Mason, Jean Janotta Guest: Beverly Lancaster

<u>Secretary's report</u> Minutes from the September 10, 2017 meeting were published in the newsletter. Anne Hubbard made a motion to waive the reading of the minutes, Kate Viles seconded. Motion approved.

Anne Hubbard made a motion to accept the minutes, Matt Mason seconded. Motion passed.

<u>Treasurer's report</u> Lee Prager sent an email the approximate account balance is \$21,000. Lee also sent the totals for HMM 2017 Conformation - \$399.57 profit

Rally/Obedience - \$102.82 profit Agility - \$64.67 profit

HMM overall - \$567.06 profit

Payment for agility course reviewers.

Altered program, quality of dogs on the decline.

Who may contact conformation judges In regard to flights, dates?

Entering trial results on line problematic.

<u>Library report</u> There is an updated list on the website which includes the new items. Lisa Andrade wondered about using duplicate items as prizes at shows. No decision was made to do so. Matt Mason asked how much the library was used and was it worth maintaining. It was suggested to maybe purge some older out-of-date items.

ASCA BOD nothing Sunshine report nothing

#### **Event updates**

- Fall Fling agility as of 11/4/17 runs for Saturday were 233 and Sunday's stood at 196.
- Jean Janotta said the 3/31 4/1/18 NH agility trial was Easter weekend again. Last year it really effected the runs on Easter Sunday. Low judge's expenses are what saved the trial. Suggestions were to be sure there were 6 runs on Saturday, could we do Saturday only or Friday and Saturday, or a seminar Sunday afternoon if the trial was going to end early again.
- Spring stock trial Art Landry had asked about moving the June stock trial to May so it would count towards Finals. May is pretty busy, the only available weekend might possibly be the first. It was thought a stock trial in NH would not draw the same exhibitors as the Obedience trial in CT on that Sunday.
- August agility trial Anne Hubbard said outdoors was hot, even with indoor crating. Other comments indoor places, especially places like a soccer arena are more expensive; would a local judge offset that additional expense; if the same weekend again as Act Up does that affect our numbers; could it be moved to Sept, if so Anne mentioned the place she trained at as a possibility; Kate Viles mentioned Sugerbush Farm (this would require talking to WASCUNY as it is in their territory); does the club want indoor or outdoor trials; would the club be better off offering less trials.

As of now, no August trial in 2018 but keep the dates available for 2019.

- HMM and stock - Anne Hubbard talked to Mark Gary at the fairgrounds about the possibility of hiring outside help to setup and teardown the stock rings. Boy scouts - he has not had good experiences with, local prison - wants nothing to do with, best option seems to be Mark finds a couple of people to subcontract. Anne also asked about additional cost of storing more stock items such as buckets and hoses to lessen what has to be brought in. This would probably be only a small increase in fees as we pay per "bay" (our contracts for storing are with Mark and will have to be re-addressed with fairgrounds board when Mark retires). It was suggested easing back in with a duck only trial, but popular opinion was ducks alone were not a big enough draw. If going to do ducks and sheep, did not see a reason not to do all three stock. One trial a day should be sufficient, two a day is too much work. It was asked what the overall chair's duties were, it would be helpful to have a list of the different duties, could chairs get together to hire judges that could judge more than one area of competition, if we have MVA Anne said Kathy Fretz had volunteered to chair. As first step, Anne will continue to talk to Mark about workers.

- Is it time to look at all events during the year (cost, etc) and think about consolidating some?

#### Old business

<u>ASCNE by-laws</u> There are some more notes for the committee to go over. A possible timeframe would be to get the suggestions to the members at the Jan meeting, allowing time for discussion before a club decision at the ROM meeting, then the changes would have to go to ASCA for approval.

Part of the suggested changes are keeping methods of communications up to date.

Some members have asked about "Skype-type" meetings. There are a lot of questions about how it would work - how many people can be on at once, what does it cost, what if the meeting location has no WIFI, do you need a moderator, how do you allow people to talk one at a time, what equipment is needed, how are acoustics in a large room.
