# MEETING MINUTES:

ASCNE General Meeting 3/4/18 Log Cabin Restaurant, Holyoke MA

1. Anne called the meeting to order
2. Secretary's report was accepted as printed in the newsletter
3. Treasurer's report was accepted as printed in the newsletter
4. Affiliate report included recent changes by ASCA to A-frame heights in agility, Dock Diving is now a part of ASCA and ASCA Dock Jumping titles earned in one of two ways: ASCA Affiliate Club or Approved Dock Jumping organization ie Ultimate Air Dog, Obedience Judges need to do CE 7/1-12/31 annually, Rally has new signs, Conformation now has Non-Regular Breeder Judges
5. Library Report-Lisa Andrade has gone thru and removed "purged" a number of older resources from the library and they were available for free on the library table. A new librarian needs to be found as Lisa is no longer able to manage it. If no one is willing, then the ASCNE library will be dissolved. Thank you Lisa for managing it in recent years.
6. BOD business: There are plans to update the ASCNE website including a members only section and going to Word Press to allow multiple people to update it appropriately and to be able to add event photos etc. A letter was sent to ASCA by the ASCNE BOD in regards to the Contagious Disease Policy after Nationals. The ASCA BOD is taking it into consideration as they are working on changes to the current policy.
7. Colors of Summer update-Gary Shipley Seminar has 4 spaces available for Elite Dogs, Conformation plans to have 4 or 5 judges and donations are being accepted for prizes.
8. March 18<sup>th</sup> Conformation Show-need stewards and Potluck Dinner volunteers. This will be the last year that Sue Winters coordinates this show, so a new show chair is needed for 2019.
9. March Agility Trial in NH- there has been a poor turnout so far in regards to entries for that weekend
10. April 7 and 8 Obedience and Rally Events have been cancelled for this year
11. May Obedience Trial will be held in Goshen CT
12. May 12 and 13 Farm Trial in NH is scheduled to happen. Flyers and courses will be posted on website when sanctioned.
13. May 19 and 20<sup>th</sup> Agility Trial in CT is on with Diane Harrison as the judge
14. Old Business: Proposed By Law Changes will go on the website in the near future with a 3 week period for comments from the membership, then board review and submission to ASCA. If approved by ASCA then they will be voted upon by ASCNE. Anne Hubbard is going to confirm this sequence of events.
15. New Business: New Applications for Membership include the following three people and they are open for comments-Beth Adams, Christy Foss, and Nancy Cowell
16. Jean Janotta made a general Thank You announcement to all members who put the time and effort into organizing ASCNE events.
17. The meeting was adjourned and ROM award were presented.
