From Rte 95 South of Attleboro, MA:

Take Exit 2A (Newport Ave) to the first light. Take that left onto Cottage St. Follow along 1 mile and turn right on Read St. to 2nd right onto Pond St. Watch for Orion Industrial Park on right (3/10 mile). Turn into park, second building on left.

From Rte 95 North of Attleboro, MA:

MEETING MINUTES:

11/4/18 ASCNE General Membership Meeting

Location: Salisbury Town Hall 645 Old Turnpike Rd. Salisbury NH

The meeting was called to order by Anne.

- 1. Secretary's Report-Motion was made to approve with the addition of Gull's name on for attendance at the September meeting at which she was present but had not signed the attendance page. Motion passed without opposition.
- 2. Treasurer's Report-HMM made about \$2300 profit in October and the breakdown will be published on the website newsletter. The ASCNE treasury has \$28,242 in it currently and expected to be around \$25K at the end of the year after final event expenses and income. This is higher than the end of 2017. Report was accepted.
- 3. Committee Reports: Library-still being disbanded. Anne will touch base with Lisa to see what materials are left to rehome/recycle/donate. Lisa's email contact will be double checked as Lyn Scribner had not been able to reach her regarding items in the library.

Affiliate Report-Pauli noted that there is not much going on with the ASCA BOD right now but the various programs have changes being made. A detailed report will be attached to these minutes when Pauli is able to forward them. The Annual ASCNE Affiliate Report will published in the 12/2018 Aussie Times. Report accepted.

4. Old Business: 2019 Calendar Review

- a. WASCUNY and other NY ASCA club event dates will be posted on the ASCNE website.
- b. Reminder that the Nationals will be in GA in 2020, so points earned in the various programs between 6/1/19 and 5/31/20 will count towards Finals in GA for those members looking to compete and attend those Nationals.
- c. Discussed potentially moving the July ASCNE meeting to a June date to avoid the holiday weekend in 2019 and future years. Members present were in agreement.
- d. Will check with ASCME in regards to coordinating events with them too.
- e. Many events on the 2019 Calendar do not have Show Chairs/Secretaries/CDs noted which are designated with a "?". The events will be removed from the Calendar unless an ASCNE member is able to volunteer to organize the event.
 - *Conformation Shows do not have any Show Secretaries at this point in time and the BOD is aware that part of this is secondary to ASCA Conformation Rules regarding hiring and hosting judges. Ideas are being exchanged for ways to accommodate. Members

- that participate in Conformation are encouraged to contact the ASCNE BOD with suggestions on how to build up the program.
- f. The financial planning sheets (budget and expense) are ready to be distributed to 2019 chairs. The BOD requests that these be done in 2019 for all events to help get a better idea on what may help to make events financially sound. The treasurer will send them out to all Chairs/secretaries etc. A cover letter will accompany the forms.
- g. A request was made for suggestions for activities to be held in conjunction with membership meetings in 2019. Please notify the BOD. The OFA Eye Clinic went well today. Robin noted a new training facility in Milford NH, "Good MoJo" may be a site for a future meeting and activity.
- h. The ASCNE BOD voted in July to limit Agility Comp Runs to 50 per trial weekend. These runs can be distributed by the Trial Chair to volunteer workers that they choose to fill positions of Chair, Secretary, Scorekeeper, Course Builder, Ring Steward and Hospitality. The 2018 agility trials have actually held at about 45-50 Comp Runs, so the 50 run limit will be on the budgets for 2019 events.

NOTE: The present ASCNE BOD was made aware of this long standing practice early in 2018 and after much discussion voted in July 2018 to limit these "comp runs" in agility as some trial weekends had given away more runs causing significant financial losses in 2017. This limitation will allow Agility to continue this practice but limit the financial loss at events and to ASCNE over all. Compensatory runs are the "norm" in other ASCA agility clubs as well, however the other ASCA programs do not compensate their volunteers at events. The BOD is open to and is looking for ways to "give back" to ALL ASCNE MEMBERS who volunteer at events and would like to promote more volunteerism in the club rather than expectations for compensation.

i. Some present suggestions to show appreciation to volunteers in all programs include: a gift card raffle at the ROM banquet, seminars for all members, giving away a stock run or Obedience/Rally entry, Conformation entry discounts, Food/Snack tables paid by ASCNE at events. Any suggestions are welcomed.

New Business:

- 1. There are no new member applications
- The BOD voted to change the BOD Policy on Reimbursement to 14 days from 30 days after the end of an event to be consistent with the ASCA requirement and to expedite finalizing events sooner.
- 3. The BOD voted to transfer the ASCNE bank Account to Citizens Bank from Rockland Trust. This will allow availability of more local branches for the ASCNE Treasurer now and in the future. Also, Anne is meeting with Citizens Bank this coming week to establish an ASCNE Credit Card that will NOT be linked to a member's personal credit history, it will be ASCNE's.

- 4. A brief discussion was held regarding a possible Pavillion being built at Westfield Fairgrounds that may replace tents in the future for Conformation and Obedience Shows. No one at the meeting knew much about it but Anne will ask Mark about it.
- 5. Diane Johnson wanted to note how much she appreciated the hospitality and appreciation shown to her at ASCNE events after having volunteered at events in FL last winter. Kindness, and Thank you' go a long way as well as lunches or refreshments for volunteers.
- 6. The meeting was adjourned.

ASCA Proposal to Run Future Nationals:

There is a proposal posted on the <u>ASCMEMBERS@groups.io</u> list concerning a proposal that ASCA Business Office run the Nationals. ASCA is looking for comments, so please feel free to comment on these ideas.

The ASCA Board of Directors is considering a proposal for ASCA to run the National Specialty, and they would appreciate your feedback on this idea. If you have other ideas on this topic, the Board would like to hear those, too.

Currently, Affiliate Clubs or Consortiums of Affiliate Clubs put in bids to host Nationals at one of four rotating sites. For example, the 2019 Nationals will be held in Bakersfield, California, hosted by Central Valley ASC, and the 2020 Nationals will be held in Conyers, Georgia, hosted by the Georgia Consortium, made up of five Affiliate Clubs. Under the current system, these Affiliates host the Nationals, and they take financial responsibility for the Nationals, bearing the cost in the case of a loss, and taking the profits if the event is successful.

The current proposal would change this so that ASCA would run Nationals with a committee of volunteers, and all profits would go to ASCA. Affiliates could still play a part by hosting pre-shows and pre-trials. Please look over the attached proposal for more details, and let the Board know your opinion of this proposal. This is a first draft and will need continued work if the membership likes this idea, so please share your thoughts. Please send your feedback to the Board by emailing the Executive Secretary at asca.execsec@gmail.com by December 15. Thank you! The Board hopes to hear from you.

ASCA-hosted National Specialty Proposal

- 1. Starting with the 2021 ASCA National Specialty to be held in Bryan, Texas, ASCA will host the National Specialty and Finals, and all profits from the event will go to ASCA.
- 2. ASCA will form a Nationals Advisory Committee, comprised of former Nationals Chairmen, whose purpose will be to oversee ASCA's management and running of ASCA's annual National Specialty and Finals competition.

- 3. The Nationals Advisory Committee's duties will be as follows:
 - To assemble the Nationals Committee for each year. This committee will be appointed and approved by the Board at least two years, and preferably three years, ahead of the event.
 - To solicit, appoint and contract pre-trials and pre-shows for Nationals. These will be awarded two years in advance of the event. (See Section 5 below.)
 - To solicit, appoint and contract for the paid workers for each Nationals, including the entry clerk, the agility data entry clerk, stewards, stock handlers, and set-up and tear-down laborers, upon Board approval.
 - To ensure that the National Specialty operates in a manner that will provide members with an opportunity to have a pleasant experience at an efficiently run event.
 - To ensure that the National Specialty is both financially self-sustaining and cost positive for ASCA.
 - To work with ASCA's competitive program committees to ensure that rules are being followed with respect to Nationals and Finals competition. To work with other ASCA committees as needed to ensure a successful participant experience.
- 4. The Nationals Supervisory Committee will assemble a Nationals Committee for each year, filling the following positions:

Nationals and Finals Conformation Secretary (may be two separate people)

Nationals and Finals Obedience Secretary (may be two separate people)

Nationals and Finals Rally Secretary(may be two separate people)

Nationals and Finals Juniors Secretary

Nationals and Finals Agility Secretary (may be two separate people)

Tracking Secretary

MVA/MVJ Secretary

Awards and Rosettes Chairman

Sponsorship Chairman

Vendors Chairman

Hotels and Travel Chairman

Banquets/Receptions/Nightly Dinners Chairman

Merchandise Chairman

Merchandise Co-Chairman

RV/Camping/Golf Carts Chairman

Grooming Spaces/Stalls Chairman

Hospitality Chairman

Parades Chairman (if offered)

Decorations Chairman

Signage Chairman

Dock Jumping Chairman

These Nationals Committee Chairman will have their transportation, room and board paid for Nationals, but they will not be paid any cash.

5. Pre-Shows and Pre-trials

There will be two Conformation pre-shows, two Agility pre-trials, two Stockdog pre-trials, two Obedience pre-trials and two Rally pre-trials held in conjunction with the ASCA National Specialty. 5.1 Selection of Affiliate Pre-show/trial Hosts

Affiliates who are interested in holding a pre-trial or pre-show for a particular Nationals should submit their names to the Nationals Supervisory Committee by the announced deadline. All names will be put into a lottery draw for their desired event(s). An Affiliate may only host one event every four years, unless no other Affiliates are interested in hosting. The purpose of the lottery draw is to give a fair chance to all Affiliates who wish to take part in the ASCA National Specialty by hosting a pre-show/trial.

5.2 Pre-show/trial fees

The fees for hosting a pre-show/trial for the ASCA National Specialty shall be determined for each Nationals by the ASCA Board of Directors, upon recommendation of the Nationals Supervisory Committee.

5.3 Pre-show / Pre-trial Contracts

Affiliates selected to host a pre-show or pre-trial shall sign the contracts provided in this document and shall pay the deposit by the required date or the next Affiliate on the selection list will be asked to host.

6 Selection of Judges

Judges for the various Nationals and Finals events shall be selected by ASCA's program committees. If a Committee does not currently have a procedure for selecting Nationals and Finals judges, the Committee will create such a procedure and follow it, beginning with the 2021 Nationals and Finals.

7 Accounting and Financial Procedures

- 7.1 ASCA will establish a Nationals checking account for each year's National Specialty. All proceeds generated by the Nationals and Finals events will be deposited into this account. The Nationals Chairman will be the signer on this account.
- 7.2 The Nationals Bookkeeper and the Nationals Chairman will maintain a ledger, documenting all deposits and expenditures. The ASCA Treasurer, members of the Nationals Supervisory Committee, and any other interested ASCA Director will be able to view the ledger.
- 7.3 The Nationals Chairman and the Nationals Supervisory Committee will work together to prepare a budget for the National Specialty, which shall include the Finals expenditures. This budget will be approved by the Board of Directors.


