- 1. Meeting was called to order by Anne
- 2. Secretaries Report as printed in last news letter was voted on and accepted.
- 3. Treasurer's Report read by Matt-September 1, 2019 balance \$23,423.75

June Stock Trial: \$312.83 August Ob/Rally: \$(828.83)

Checks were sent to ASCA on 3/28/19 for Finals-\$2000, and Nationals-\$1500

HMM Chairs are asked to send requests for HMM to the Treasurer by 9/29/19 to assure Jen can get them to everyone for that weekend while she competes and volunteers too.

Affiliate Report by Pauli:- ASCA Finals will not be held in OR in 2023, an new site is being sought, ring stewards are not allowed to comment on exhibitors, Judges for shows need to be determined at least 45 days in advance, and ASCA has given \$1000 to a BC research study because some Aussies are also afflicted with a similar disease.
- 5. Nominating Committee: Notified the membership that we are looking for a third member and Kathy Chouinard volunteered. Committee now consists of Matt Mason, Karen Souza and Kathy Chouinard. - The Novice A Class is for handlers that have not placed an Obedience or Rally title on a dog from ASCA or any registry and the dog does not have an Obedience or Rally title from any registry.
- All dogs competing for ASCA Rally titles are required to start at Novice and work through Masters regardless of Rally titles awarded by other Registries.
- No entry shall be accepted from a dog or handler disqualified from the ASCA Conformation program; a dog or handler disqualified from all ASCA programs; or a person not in good standing with ASCA

Registration & Tracking

All Australian Shepherds over the age of 6 months must be registered.

Effective January 1, 2004: All dogs six (6) months and older must have an individual ASCA registration or LEP number or and ASCA tracking (QTracker) number to compete in ASCA sanctioned Obedience Trials. A dog will be allowed to be shown at the trial where the handler applies for an ASCA tracking number. The handler will be issued a receipt by the Registration table valid for sixty (60) days to allow the Business Office time to issue the tracking number. Photo copies or originals of registration or tracking number papers must be presented to the Registration Table upon request when entering ASCA sanctioned
