From Rte 95 South of Attleboro, MA:

Take Exit 2A (Newport Ave) to the first light. Take that left onto Cottage St. Follow along 1 mile and turn right on Read St. to 2nd right onto Pond St. Watch for Orion Industrial Park on right (3/10 mile). Turn into park, second building on left.

From Rte 95 North of Attleboro, MA:

Take Exit 3B/Rte 123. After fire station take left onto Read St. Follow to stop sign, turn right and immediate left onto Read St. (There are signs for the animal shelter) Take 2nd right onto Pond St. Watch for Orion Industrial Park on right (3/10 mile). Turn into park, second building on left.

From Rte 195 East or West:

Take Massachusetts Exit 1. Follow 114A North. In approximately one mile you will reach a fork in the road, bear right (Grist Mill restaurant is on your left). This is Arcade St. You will come to intersection of Rte 44. Go straight across and continue on Arcade to the end. This is junction of Rte 152. Take a right onto 152 North / Newman Ave. Follow for about 5 miles to intersection of Central Ave (after Rojacks). Go 1/2 mile and take left onto Pond St. Watch for Orion Industrial Park on left. Turn into park, second building on left.



Saturday AM - AKC CH Moonstone Terra-Blue crank it up "Colt" Blizard for a 3 point major.



MEETING MINUTES:

November 3, 2019 ASCNE BOD and Membership meeting combined

Good Mojo University 308 Elm St. Milford NH

BOD Present: Anne, Jen, Alicia, Matt, Gull and Pauli

The meeting was called to order by Anne

- 1. Secretaries Report was accepted as published in the last newsletter.
- 2. Treasurer's Report: \$27,280.86 in the account presently but still waiting on HMM checks and bills to be submitted. Rough numbers presently show approximately \$3,000 income from Agility, Obedience likely broke even or a profit, Stock may be at a loss, and Conformation may have ended around \$2,000 to the positive.

All chairs are reminded to send in checks and expenses within 2 weeks to the ASCNE Treasurer.

- 3. Affiliate Report: a.ASCA Rally has new classes listed that are not for titling yet including Pairs which includes 2 dogs and 2 handlers, Brace is 2 dogs and 1 handler and Team which is 4 dogs and 4 handlers.
 - b. The ASCA Scent program will be introduced at Nationals in CA
 - c. ASGHI- wants to clarify that Heart Diseases are hereditary
 - d. Obedience changes have been made to the program and will be effective June 2020 which include changes to Novice sit/stay and long sit/stay for one minute on leash
- 4. Nominating Committee: Matt read the present nominations for ASCNE BOD as updated at the meeting

President: Matt Mason or Lee Prager Vice President: Wendy Richmond

Treasurer: Steven Phillips Secretary: Kathy Peloquin Affiliate Rep: Cindy King

Members at large: Gull Gullicksen and Alicia Campbell

Nominations can be accepted until November 15th per the By-Laws and all nominees are encouraged/invited to send a letter to the committee to be published and posted on ASCNE-L, ASCNE FB, in the newsletter and on the website. Ballots will be mailed by November 20th and will be counted on December 15th per the ASCNE By-Laws.

Old Business:

- 1. Credit Card update. It was approved by Citizens Bank, however the documents to be signed do not apply to a non-profit organization/business. Anne is continuing to forge ahead to resolve this issue with the bank.
- 2. HMM updates: Thank you for the efforts put into the 25th Celebration. Membership present felt that it was a good effort and appreciated by attendees. Items were sold out

early, \$675 worth of orders. The raffle for pre-entries went well as did the Potluck Dinner on Saturday night. Obedience went well on Friday afternoon and Barbara Barreiro questioned if they would be the only ones competing on Fridays in the future. They had great participation but the other events did not happen until Saturday. Brief discussion explained that 2021 plan will have to wait until later in 2020, but Friday shows have been difficult to set up and attend secondary to the smaller size of the club and participant levels being lower than years past.

- 3. Cranberry Classic update: It is happening and it will be a Rally competition to the best of the knowledge of those in attendance at the meeting.
- 4. Fall Fling: low number of entries at present time.
- 2020 Calendar: a. The COS show weekend needs an over all Chair as well as an Agility Chair.
 Lee Prager is willing to mentor someone for the agility chair. Barbara Barreiro is willing to Chair the Ob/Rally portion
- b. March and May Agility sites need to be confirmed still per Jean Janotta New Business:
- 1.Update of Website- BOD is looking for an advisory committee to work with Robin Goodman to establish what the membership would like to see on an updated website so that the BOD can look for a designer to build it.
- 2. Possible Cattle Farm Trial site in Hopkinton NH, donated by Mike St. Laurent, but an ASCNE member needs to be the CD. Matt is willing to mentor.
- 3. Matt will be talking to Jim Hartnagle about a clinic in June after COS while he is in New England
 - 4.ASC of ME Stock trials will be July 16-20, in 2020
- 5. Tufts Veterinary Nutritionist, Dr. Deborah Linder, is willing to do a talk for ASCNE in February or April. An April date was preferred by the membership present to avoid bad weather. Event may be held at Good Mojo University if a date can be secured.
- 6. Open discussion about recruiting new volunteers and members to ASCNE thru various events and activities, but it will be difficult secondary to the large volume of canine events available these days.
- 7. The members present liked the Good Mojo University facility and will try to use it for future events when possible.
 - 8. Next meeting scheduled for January 5, 2020-Canine Mastery in Seekonk, MA
 - 9. Meeting was adjourned

Presenter: Laura Allen gave an informative talk and powerpoint presentation on her involvement with SAR work and training her Aussies to do the work. The membership enjoyed Laura's talk and watched while her older Aussie, Casey, located Jean hiding in an area of the room. Talented dog/handler team.

UPDATES FOR 2020 EVENTS:

Under New Business at the November 3rd meeting, a few announcements were made and since that time, more definitive plans are underway.

- 1. Denise Bonyun from VT is willing to be the CD for Cattle Farm Trials to be held at Mike St. Laurent's "Bitter End Farm" in Hopkinton NH. Matt Mason is assisting Denise with the process and a judge is being sought. If possible, a stockdog clinic will occur after the trial weekend. At this point in time, the Farm Trials may occur one of the weekends in late September. Stay tuned for more information to come.
- 2. The Farm Trials with NH Sheep and Wool Festival will be May 9 and 10, 2020. At this time, it looks like Jim Hartnagle from CO will come out to judge the trials and then do a 2-3 day clinic in NH after the trial weekend rather than doing one in June when numerous other herding events are typically scheduled in NE.
- 3. The Canine Nutrition talk being presented by Dr. Deborah Linder from Tufts Veterinary School has been scheduled to be held on Saturday April 11, 2020 at Good Mojo University in Milford NH. The room has been reserved from 10-2 to allow for set up and clean up as well as time for her presentation and questions. More information will be provided as it gets closer. Potential topics to be covered are how to choose a dog food, updates on nutritional cardiomyopathy, home cooked dog foods, balancing nutrition and raw diets. If you have any other suggestions to help her develop her presentation, please send them along to Matt at masonpr@tds.net. The plan is to have this event free to ASCNE members and a fee for non-members. It will be advertised and promoted with a request for RSVP so that enough space will be available for attendees.

BOARD OF DIRECTORS CANDIDATE STATEMENTS:

Letters were submitted to the Nominating Committee by two candidates: Matt Mason and Lee Prager. They are presented below in alphabetical order, by last name.

From Matt Mason:

November 13, 2019

I am Matt Mason and I am volunteering to run for President of ASCNE. I have been an active member of ASCNE for over 20 years and have owned, trained and competed with many Aussies over the past 28 years having purchased my first one during Veterinary School, Propwash Marco Polo. I never could have imagined back then how important these dogs would become in my life, but he and many others taught me to appreciate this breed with their many talents and the diversity of the people that enjoy them.

When I joined ASCNE, I was one of the "young ones" and the club became a great source of friendship and a hobby that provided new experiences and opportunities to work with and learn about the various aspects of the breed. I attended a lot of Conformation shows and watched Obedience matches in awe of handlers while I did my best to develop obedient companion Aussies thru a local obedience organization. A lot of my early volunteer time to ASCNE was with the rescue program that was maintained by the club. As a veterinarian, I was able to provide surgical and medical care for Aussies in need of a second chance while also fostering many of them. Unfortunately not all were adoptable but the ASCNE Rescue volunteers did their best for many adoptable Aussies that needed a chance. It was not easy, but it was rewarding to work with the talents and resources of various club members to help these dogs as well as educate the humans that adopted them into their lives.

As I became more involved with ASCNE, I was introduced to the stockdog program and I admit that I was bitten by the bug. The program in New England was in its infancy and a lot of help was recruited to pull off events, and I joined the efforts without regrets so that I could learn more and eventually be able to compete. I have been the CD for many arena trial weekends as well as more recent farm trial programs. I have hosted numerous herding clinics over the years for ASCNE as well as club meetings and "try it" days. Livestock availability for stockdog trials was always an issue to pull off events and I decided to help the cause by raising sheep and ducks and eventually cattle and goats to be used for events to further promote ASCA and ASCNE events. In spite of volunteering for ASCNE in my "time off" from a busy veterinary practice, I managed to compete well in stockdog events and succeeded in completing 11 WTCH titles, with two dogs qualifying for the Finals in 2009 in all three livestock.

Volunteering and involvement in ASCNE has introduced me to many people and activities over the years and I would not trade those experiences for anything. The club developed from people that stepped forward over the years to selflessly organize and run events for the benefit of everyone because if they did not volunteer, then events would not have happened and ASCNE would not have developed. I would like to provide similar opportunities to future generations based upon volunteerism from everyone and appreciation of successful events for many to enjoy. I have been an active member of the ASCNE BOD as the Secretary for the past two years and I am willing to volunteer my time for another two years to help promote ASCNE thru competitive and educational events for many dog owners while continuing to be fiscally responsible for the future of ASCNE.

From Lee Prager:

- What would you like to see improved and in which programs?
- Are you willing to volunteer to help the club improve?

If these questions interest you, then please read on:

I was recently asked why I was running for President of ASCNE. My answer is: "I want to take action to improve the overall experience of our members, not stand on the side and wish things were different."

I believe the strength of ASCNE is in its diversity – the ability to organize events for all programs.

However, I have heard members ask, "what do members get by joining ASCNE", i.e. "what's in it for me?" I would like to see the club move in a direction where that question gets answered. As president I would focus on 3 main tasks:

- Organize the ASCNE board to have a leader responsible for each program (Agility, Conformation, Herding, and Obedience/Rally).

- Have each responsible leader publish a 2-year plan to accomplish the improvements needed for their program and communicate their plan's progress in each publication of the newsletter.

As president my job would be to create a closer bond between the leaders of each program, utilizing each other's strengths to enhance where others may be weaker, thus creating a community culture. This would allow us to identify a mission and vision statement that overlaps each discipline and identifies the root motivation of membership.

What skills do I bring to the job?

I have had a successful career managing a world-wide planning group that designed premium, branded audio systems into new vehicles. This included multiple communication points and negotiations with the major automotive companies across the globe. This also involved working across various cultures within my group, combining different strengths to institutionalize ideas and best practices into a common global team.
