EOUIPMENT:

Slatless teeter, Slatted A-frame and dogwalk will be used. Jumps, including double, tunnels, chutes may be used at the judge's discretion. **Electronic timing will be used at this event.**

PRIZES AND AWARDS:

Qualifying and 1_{st} through 4_{th} place ribbons will be awarded in each class. Placements will be combined for 20+ and 24'' dogs in all divisions. A rosette will be awarded for new titles and ATCH.

REFUNDS

There will be no refund for entries withdrawn after the closing date, except for a dog's injury and/or illness or for bitches that come into season after the closing date. These entries will be eligible for a refund of the amount of the total entry fee less \$15. A signed letter from your veterinarian must be included with your written request. - A dog may be entered in a class at a jump height higher than they are eligible provided the dog is not entered in the Junior Handler or Veteran Division classes.
- No dog shall ever jump lower than 4" in the Junior Handler or Veteran Division and no dog shall ever jump lower than 8" in the Standard Division.
- Any exhibitor whose dog measures over 20" may choose to enter the 20+ class or the optional 24" class. 20+ and 24 will be scored and placed together as one class.
